Aligning My Will

I came into these rooms like most, spiritually broken and angry. Felt so uncomfortable with the prayers and "God" stuff I almost left. But for some reason I didn't.

I realized after a short while that if I was going to try this sobriety thing, I really was going to have to go all in... "half measures avail us nothing". So being the person I am, I made appointments with a couple of ministers to see how they came to believe. These men were so generous with their time, and patient and tolerant with my rants of how God had abandoned me. Each of them, independently smiled and the last thing they said to me was "You will become a disciple of His word". I explained that they had no clue who I was, that this would never happen.

Then I stumbled my way through the steps, and began to have this thing called hope, which with time became faith. I prayed, and tried to mediate and listen for "God's" word. Then quite by accident, the game-changer happened to me.

I started going to meetings in detox and treatment facilities. I had a lot of "experience in the addiction", but little (or so I thought) in the "strength" or "hope" categories. But I had more than some of the people in these places, and I shared with them about how I had stayed sober for 90 days, then 6 months, then a year, then for multiple years.

I realized in those rooms that I had become a messager of "His" word. "He" was Bill W. And Bill W's word was, I believe, divinely inspired. So today I find that my will aligns best with my

A Proper Use ...

The proper use of the will is stated very clearly on Page 85 in the Big Book. I must strive to do my Higher Power's will each day in all my activities. In other words I start my day by praying "Thy will not mine be done" and "May I do Thy will always." When I pray for special intentions, I say "If it be Thy will. These are phrases I do not take lightly.

Why do I do this each morning, each night and often during the day? My will took me to the brink of suicide. I was a disaster at managing my own life. I was selfish, thoughtless, unkind, hurtful and resentful to those I loved most. I was all I thought about. I was untrustworthy, and never around when someone needed me. I spent the end of each day alone, contemplating life through the end of a wine bottle. And the next morning, I was disappointed to find out that I have lived through the night.

When I reached out for help with my drinking, it was an admission of powerlessness. It was very clear to me that I was indeed powerless over alcohol. I had been for many years. That admission is the first time I turned my life and my will over to my Higher Power. I am granted a daily reprieve from the grip of alcoholism only through the maintenance of my spiritual condition. Going to meetings, working with my sponsor and reading the Literature are some of the ways I maintain my conscious contact with my H.P.

Today, through prayer and meditation, I ask to know my Higher Power's will for me so that I may be useful to Him/Her and to my fellows.

higher power when I'm reaching out to help someone who is suffering, who is lost, and who is hopeless – like someone did for me just a few years ago.

If you are concerned that sobriety isn't for you, or that you don't understand the difference between your will and your Higher Power's, maybe you can find it by taking your message of hope (however small) into treatment meetings. That's how it worked for me. And I'll keep coming back.


Old Business: None.




