#### A Friend Among Friends, a Worker Among Workers

"But it is from our twisted relations with family, friends and society at large, that many of us have suffered the most. .....The primary fact that we fail to recognize, is our total inability to

form a true partnership with another human being..... We have, not once, sought to be one in a family, a friend among friends, a worker among workers, to be a useful member of society." (*Twelve and Twelve*, page 53)

Step four in the *Twelve* and *Twelve* was just plain scary at first read. It talks about misdirected instincts, mental liabilities, emotional deformities, disillusionment, helplessness, perverse soulsickness, erratic emotions,

vengeful resentments, unwarranted pride, etc. By doing steps 2 and 3, I had just received the hope that someone like me could actually be a peaceful and useful member of the human race and perhaps sometimes feel at ease in my own skin! Apparently, the program (steps) will help me to be at ease with other people as well.

The chapter "Into Action" in the Big Book reminds me that I had agreed in the beginning to go to any lengths to achieve victory over alcohol. Then I find out that "our real purpose is to fit ourselves to be of maximum service to God and the people about us". The middle six steps remove the garbage that blocks me from God and my fellow man, and also give me a shot at some humility: the process of getting a little further away from that painful state of selfabsorption. I get to be useful to God and my fellow humans. I get to be an average person, a



regular guy. Come to think of it, my goal in coming to AA was to heat escape the of regulatory agencies, to dive under the radar. I most definitely did NOT intend to fit in with a bunch of rather eclectic and bizarre ex-drunks. In fact, I really didn't want to belong to ANY group of humans! I lived alone and I drank alone.

By virtue of those middle six steps and the

subsequent maintenance/growth steps of 10 through 12, I have been tricked into walking the Earth a free man by the grace of God. In step 10 I can make sure to keep my life and relations with other people in order. In step 11 I have an opportunity to seek God's will to the best of my ability (falling short every day of course), and in step 12 I get to practice "fitting in" by simply showing up to life and being a humble servant to the best of my ability. I am so grateful for my sponsor and the good men and women around me who have shown me how easy all of this is! Trust God, clean house, and help others.

We are selling a lot of the large print versions of the Big Book and other literature. The copies are a little more expensive to purchase.



#### **Our Traditional Right of Appeal**

Concept 5 maintains that "Throughout our world service structure, a traditional 'Right of Appeal' ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered." Does this apply in my daily affairs?

In my childhood and teenage years, my parents never required my opinion. At school I was a loner. I was a minority in and outside my home. As an adult I remained silent at home and at work to avoid conflict.

In AA, however, I have seen Concept 5 work and it leads me to use it in my daily affairs. If people do not engage in discussion, I stop to consider what they are thinking...that theirs is the minority opinion no one wants to hear. If a vote carries the majority opinion, I ask the reasons behind the minority's vote. In A.A., Concept 5 provides that a convincing minority opinion after a vote can lead to a re-vote and a change in the outcome. I feel a duty now to express my opinions with honesty, openness, and good will.


