# "The Spiritual Awakening of Selflessness...."

It was on the wall: "Trust God, Clean House, Help Others." Those three simple ideas are absolutely counter-intuitive to most of us when we get here. I was always plagued by the *why* questions. Why do we have to trust God (we need faith to be effective), why do we need to clean house (we need quiet minds to efficiently let God into our lives), and why do we help others (to get an open heart and to let God flow through us). The chapter "Into Action" fires off

7 steps in 16 pages and stops abruptly after step 11, only to leave "Working with Others" as the crowning glory of the steps; a whole chapter devoted to the selfless pursuit of service. How could this be so important?

New in recovery, I was very confused about *all* of the steps, especially that last one. The 12th step looked like a *top shelf* extra credit step for over-achievers. Over

time I realized that the altruistic attitude of service is the result of that psychic change that Carl Jung talked about. What is needed for each step, if you think about it, is willingness and humility and, for me, that was especially true when helping others. I need to be willing to put other's needs before mine (compassion), and I need to be humble enough to put myself in their shoes (empathy). Step 12 states "having <u>had</u> a spiritual awakening as a result of these steps." This suggests that, by this time, I have had that


psychic change sufficient to "relieve me of the bondage of self."

The 12 & 12 says of step 12: "here we begin to practice all Twelve Steps of the program in our daily lives so that we and those about us may find emotional sobriety." When I first read that line I believed that this emotional stability and maturity was not even vaguely possible in my life. The old timers assured me that not only

was it possible, but also a matter of life and death. I cannot tell you how many times I've been quoted page 20 from the Big Book: "Our very lives, as ex-problem drinkers, depend upon the constant thought of others and how we may help meet their needs."

Another way that it has been put to me is the notion that "to whom much is given, much shall be required." I was told early on that if I was enjoying being sober that maybe

I could show that gratitude in my actions towards service to others. Fortunately we have ample guidance on how to get busy in service. It was strongly suggested that my service can begin by becoming active in my home group, by sponsoring other men, joining various committees, bringing meetings to underserved areas (i.e. detox), etc. The social attachment and bonding that results from unselfish concern for others is, in my opinion, that special spark that God has given us to spread His love.

# Why I Give it Away...

It is one of the great paradoxes of the program that we have to give it away to keep it. This was difficult for me to get my mind around, but it is the basis of what Bill & Bob found to be a vital part of staying sober from the very start.

My nature is to be selfish and lazy. I want it to be easy, and delivered to me on a silver platter. I don't like getting outside of my comfort zone. Looking back it seems completely ridiculous that I was willing to stay in that miserable state of drunkenness, but it was what I knew. And my alcoholism had me so desperately afraid of change that it kept me locked into my bottles. So how does this giving-it-away thing work, and why must I do it? For me, it is twofold:

First, when I volunteer my time and offer my story to someone who is new; I come up close and personal to how it was for me. I get eye-to-eye with the hopelessness, and it helps me remember how it really is to be out there drinking.

Second, it gives my past a purpose. By sharing what I was like, what happened and what I am like today, I am uniquely qualified to reach someone suffering from alcoholism. A doctor who hasn't gone through the "pitiful and incomprehensible demoralization" can't do that.

The hardest part of giving my experience, strength and hope away is that it doesn't save them. But it will always save me from the insanity of my disease. So for this alcoholic, I will gladly give it away whenever possible, because I never want a drink to look like a good idea ever again.


