From Desperation to Deliverance

Many sponsors have us list the wild and crazy (shameful and embarrassing) things we did as active drunks as proof positive that we are, indeed, powerless over alcohol - that our lives were unmanageable. Although we all have different details in our first step information, the mental torment and spiritual bankruptcy we

felt are virtually identical. The horrors of our disease define our membership in a group of (former) hopelessly lost and broken people and, in my case, the unspeakable pain has led me to my finest spiritual growth.

My first exposure to recovery was at a tender age of 25 in a Pennsylvania small town AA meeting. I was indeed powerless over alcohol, but I was sure that I had simply overlooked a very important management tactic for my "drinking career." I believed the men and women at that meeting, their stories of hopelessness and transformation, were real for them. They had obviously given up! They had admitted defeat! How sad, I thought. I was so different from these poor souls because I still had plenty of fight left in me! Little did I know that the "incomprehensible demoralization" was already in the making. The next eight years were an exercise in self-loathing, self-pity, and isolation. I had imagined that I wasn't through because I still had a job, a car, some money, and no felonies. But those feelings of emptiness,

sliminess, and self-disgust are the exact same for all of us, I believe.

When I finally got sober I had the wonderful gift of desperation and an eager desire to avoid any further suffering. I believed that all of you had found some degree of peace, but that I was beyond redemption. My patient sponsor

assured me that IF I would follow a simple course of action, that I would be just fine. Taking the third step commits me to the course of action that will erase the gripping emotional and spiritual hopelessness of active alcoholism. With each step my attitude turned more positive. What

was once a vague belief that the program might work turned into a true faith in God, the program (steps), and my AA family. By the time I was working with others, I knew without a doubt that God (quite often through you) was doing for me what I could not do for myself. I also get to watch other men transform into the people they always wanted to be. What a gift!

It is indeed a matter of amazing grace that a hopelessly lost soul like me could find redemption and peace. I am so grateful that God saw fit to allow me to be usefully whole by virtue of the many people who altruistically escorted me from the darkest depths of despair. Thank you all for keeping the love moving forward!




