"As psychiatrists have often observed, defiance is the outstanding characteristic of many an alcoholic." (12&12 p. 31)

The 12&12 has many references to rebellion and defiance. That charming characteristic of my misshapen personality kept me from coming to Alcoholics Anonymous, from surrendering to a Higher Power, from getting a sponsor, from working the steps, etc. When working the 4th and 5th steps, it came up often as my role in many harms done, resentments, and the usual variety of self-inflicted injuries. Ouch! I have always bragged about being a "contrarian", that I was (in fact) exempt from the normal rules and limits of human existence. How arrogant!

No surprise at all to find out that this stubborn defiance and rebellion were mere symptoms of fear and pride, both of which are the core roots of every character defect I've ever had the pleasure of investigating. But that's the good news too; it's *only* fear and pride, the two dimensional goblins that have formerly plagued my psyche.

Fortunately, following a few simple directions, I can walk the earth a free man. Steps 4 and 5 show me the basic flaws (pride and fear); steps 6 and 7 allow me to submit these to my Creator for correction; steps 8 and 9 let me get right with other people. Steps 10,11, & 12 let me maintain and enhance this spiritual path. My job is to surrender, continually: willingness and humility is the key....

Living in the Present

At a recent discussion meeting, the topic was, "living in the day." The newcomer who had brought it up, asked how was one supposed to do that, particularly since he was new to recovery and was facing the consequences of his past. As the sharing went around the room I had time to think about my response, (missing everything that was shared of course), and I came up with an interesting but unique analogy.

My sponsor has always emphasized that the 4th and 5th steps will always lead to the two basic core issues of pride and fear. He guided me through my 5th, making certain I mentally

connected the dots until I could see that my behaviors in all my affairs resulted in either, or both, of those being triggered.

It is with that in mind that I was able to construct a concept of a timeline using the analogy of the mathematical numerical line with 0 being "the present" at the center, negative numbers increasing to the left and positive numbers increasing to the right. If the negative numbers represent the past which, for most alcoholics, is rich with shame and regret (pride), then the further in that direction, the

As the timeline between the past and the future is shrunk to a point where there is little or no distance in either direction and subsequently, neither regret of the past nor fear of the future is factored in, we find ourselves at 0 or, living in the moment and, at peace.


