My journey in AA has seen many blessings in a variety of avenues. In addition to gaining a newfound serenity, and a tool kit for dealing with life's stressful situation,

I have a better relationship with my family. I was 21 when I became sober and this was a great relief for my mother who had been in the program for almost 3 years at this point. She must have read the big book and taken its suggestions because she never pushed the program on me despite great evidence that drugs and alcohol were ruining my life.

She passively suggested I join her in going to a meeting one time after I had some type of breakdown. I remember being greatly uncomfortable at the meeting and nothing I heard made me want to go back. I just wasn't ready.

Having a parent in the program gave me a better perspective of her struggle and allowed our relationship to grow on the basis of relating to one another. We both remember the times the other couldn't remember because of this disease. Ugly as these times were, they serve as a reminder of how serious this disease is.

Today I can be a support system to my mother and she can do the same for me. Its so heartwarming to be each others cheerleader. Our relationship was never cold or rocky but it truly has grown in the fourth dimension today because of our shared struggle. Its really nice to be able to attend a meeting with my mother. We walk in as mother and son, but by the time "How it works" has been read, we are simply two members of Alcoholics Anonymous.

I'm especially grateful for Tradition Ten, where it is suggested that AA groups never get involved in the messy business of debating outside issues. The wonderful "extra" implied by this Tradition is that I, as an individual recovering alcoholic, am free to simply enjoy sobriety in AA, without having to defend my position on any outside issue.

Today, I'm sober and grateful for what it was like, what happened, and what it's like now. I'm even grateful to my parents, who put up with me as an active alcoholic. But I'm especially grateful to the alcoholics who founded this Fellowship and gave us the guidelines by which we run our groups. Tradition Ten frees AAs to concentrate on what we have in common—recovery, unity, service—rather than waste time debating outside issues.

Willingness vs Willfulness

Perhaps the greatest gift that comes from steps 4 and 5 (and also 10) is the awareness that there is a common denominator to my many conflicts with people, institutions, and principles. The problem was me, and my willful and defiant attitude. The fourth column of the fourth step ("my role in the problem") shows me that pattern so very clearly. If awareness were enough we would have no problems with recovery from alcoholism. But then there is that moment when I realized that willpower was useless

against this disease. On page 45 of the Big Book (We Agnostics) it talks about this failure that happens to us all "Our human resources, as marshaled by the will, were not sufficient: they failed utterly". Perhaps this is why it takes many of us so long to make it to AA. I was pretty sure I was powerless over alcohol but I had no doubt that it was merely a management problem. I imagined that sooner or later I could find a way to stay happily inebriated without consequences.

The problem is that when I got sober I still had an impulsive willful nature. Thank God for good sponsors who can reign in our "bright ideas". My first sponsor actually told me to do the opposite of any impulsive thought..... That seemed kind of cruel, but right on the mark! This still is a perfect opportunity to use part of the 10th step (spot-check inventory) when a hasty spontaneous idea comes to mind.

It seems that every one of our 12 steps require willingness and that, in turn, demands a certain surrender from the bondage of self (ego). Therefore, the prime ingredient for successful recovery is humble surrender. With step 3 we surrender our life and will to God, in step 7 we again surrender our willfulness to our Higher Power, and then in step 11 we work on becoming more attuned to His will.

I can safely say that, at this point most of us have been on this spiritual path long enough to know right from wrong, healthy from unhealthy, and self-centered vs God-centered behavior. Furthermore we all have a sponsor and our support "team" to consult at a moments notice. Many years ago I might have had a flimsy excuse because cell phones were rare, but now we all have instant communication that's always available. No excuses left.....

My willfulness certainly has caused most of the pain in my life according to my various inventories. Willingness, on the other hand, has caused almost all of the pleasant and productive parts of my life. Looks like we just have a simple choice: do I want happiness and peace or misery and chaos? I am so very grateful that I have the program and a loving recovery family that can help me grow, day by day, in alignment with God's will.

- There was some discussion of changing the ticket price for the Gratitude Dinner back to \$10. It was pointed out that the price of food has gone up from 3 years ago when it was changed to \$15, so there will be no change.

M made a motion to adjourn, B seconded. Meeting adjourned at 1:45pm with the Responsibility Pledge.



"Continued to take personal inventory, and when we were wrong promptly admitted it."

"KNOW thyself," Socrates advised. A later philosophical insight made it even more imperative: "The unexamined life is not worth living." Both these tenets have a bearing on Step Ten, which is supposed to keep AA members' lives under "continued" examination.

.... It was only when I learned, through AA, the difference between a creative and energizing self-examination and mere brooding over the past, that the psychotherapy took hold. According to Step Ten, mere examination-"personal inventory"--is not enough. In addition, you have to "admit it promptly" when you're wrong.

This word "wrong" implies a set of values. Before I can admit I'm wrong I must have in mind some notion of what I think is right. When I first came into the Movement I was confused about right and wrong and had no clear notion of what my life was for. Gradually, through going to meetings, reading, and AA give-and-take, I became capable of answering life's two basic questions--"Who am I?" and "What am I for?"--with greater confidence. Who am I? A midtwentieth-century alcoholic snatched from self-destruction by a Higher Power. What am I for? To make some daily contribution, however small, toward the betterment of the human society in which I have been placed.




