## Staying in the Moment -Choosing a Peaceful Life!

For many of us, as alcoholism brutalized our lives, the idea of living with the collateral damage in our lives was unbearable and there seemed to be no way out of this murky mire. Miraculously we made it to the rooms of AA through no effort on our part only to be faced with another dilemma. The "tool kit" offered to the newcomer includes some shockingly novel concepts such as reliance on a Higher Power and living in the present.

The concept of being "present" in my own life seemed like a philosophy for simpletons- people who were mentally and intellectually incapable of micromanaging their future while analyzing the past. The slogans "just for today" and "one day at a time" seemed to confirm that I had joined a cult of mentally inferior people! I soon learned that most of my fellow AAs were actually highly intelligent lifeforms. Why would smart people (with similarly over-active minds) have such a party-line mentality? What could possible be the advantage of living "right here, right now"?

Thank God for the steps like 4 and 5 which show me how much of my life is wasted on regrets of the past and fears of the future. Those two items alone have been responsible for almost all of the chaos, drama, and pain I have ever experienced. Steps 8 and 9 have purged me of the guilt, shame, and regret of the past. Steps 3,7, and 11 get me an intimate relationship with a loving God of my understanding, a Higher Power who operates in this current place and time. If I choose to continue to be courageous and trust God, then the past and future are irrelevant. In exchange, my daily task is to simply be the very best steward of the gifts I find in my present extra ordinary life. The result is a quiet mind and an open heart- a peace that each of us craved for a very long time!

Easier said than done? Not so. This is simply another example of where we (once again) surrender. I have to give up the illusions of control with the firm knowledge that worry or manipulating outcomes has never been productive, and that God really is in charge. I practice "relaxing" into the present, as a mere passenger in this wonderful experience we call life- I no longer drive the bus. I thank God and our program for the opportunity to be able to practice peace, and to live as a useful and positive force in this present moment.

- 9. Don't sit around brooding; catch up on reading, museums, walks, letters.
- 10. Don't project about holiday temptations: remember "One day at a time."
- 11. Even if you cannot give material gifts, enjoy the beauty of holiday love.
- 12. Carry the message. Give the joy away, and it will be yours to keep.

In my drinking days, I was a seven-day, around-the-clock toper. Now I know that in the Twelve Steps and especially in the final phrase, "in all our affairs," I have something to fill each day of my life just as completely, around the clock.

All I need do is listen a little, read a little, do a little, and think a little. In all history, was there ever such a bargain?


