

God Dots...

A few months into sobriety, I participated in a women's step study. One of our early assignments was to come up with the God dots in our life and recovery. These were coincidences that were clear indicators of the presence of God in our lives. As a newcomer who was struggling to find my higher power . . . ANY higher power, I found this to be a difficult exercise. So, I just began to think of the coincidences in my life that had brought me into recovery. Even after completing the exercise, I wasn't convinced that it was a god thing.

Not long after the exercise, I attempted to relapse. By that, I mean that I sat in 4th dimension and a craving hit me hard. Instead of speaking out, I began to think about how I was going to go straight to the liquor store after the meeting. Then, I would drive the five minutes home and bury myself in the bottle. My husband had left for a work obligation before I left for the meeting. So, it would be perfect!

I got home and eagerly walked inside to find my husband who glanced down at the bottle of liquor in my hand and began screaming. "Shouldn't you call your freakin' sponsor?!" Ultimately, I relented and called my sponsor in tears unsure of whether I would get off the phone with her and get wasted anyway. (I did not).

I still don't know why my husband came home from work that night other than a feeling of dread that had compelled him to return home . . . well . . . that and the "God" thing.

So, when people ask me about coincidences in AA, I return to the old standard response:

"There is no such thing as a coincidence".

Step 5

"Admitted to God, to ourselves, and to another human being the exact nature of our wrongs."

My first Fifth Step was as gentle as my sponsor could make it for me. I trusted her, that wasn't the problem. It was that I had spent my life trying to impress others, she was no exception. I didn't want her to think less of me after sharing my deepest darkest secrets. I avoided doing my fifth step with her for months. When I finally sat down with her, it was so comfortable. We worked through it together and I felt relief. It was not the most perfect Fifth Step, but it was what I could do that day. I have since done more thorough ones since I find there are many times in life when working the 4th and 5th steps is necessary in order to clear my conscience and make amends to those I have wronged.

As a sponsor, I regard hearing a Fifth Step as a solemn responsibility. My job is to help my sponsee look at her past behavior, find patterns of character defects and people she has harmed by her behavior. I try to provide a quiet space and plenty of time to work through this process. In the end it is spiritual for both of us, we are both following the 12 Steps of AA to improve our conscious contact with our higher power.

*“Each Group has but one primary purpose -
To carry the message to the alcoholic who still suffers.”*

Tradition Five is not just our primary purpose, *it is our sole purpose.* The Alcoholic Anonymous tradition of one drunk carrying the message to another is the secret to our success. The first drunk shares his/her experience strength and hope with another. The second drunk listens and decides for himself whether he is willing to follow this path. Not all do, but many, for the first time, have been able to stay sober this way. Thus far, AA's 12 Steps and 12 Traditions have helped more people stay sober than any other method.

AA must stay focused and united on this purpose, avoiding the distractions of trying to solve the myriad of other problems of drunks let alone the rest of humanity. AA is not a Credit Union, nor a hospital, it is not licensed to provide counseling on marital or parental issues. We can only share our personal experience strength and hope regarding alcoholism. We do this to keep ourselves sober. We cannot keep it without giving it away.

Recently I was reminded of this Tradition as I sat in a meeting where one person was complaining about a litany of personal problems. The person was giving no thought to potential solutions by using the Steps. While we were sympathetic, it was uncomfortable for many in the room. Luckily the meeting chair, a person with many years in the program, gently but firmly guided the person sharing to think about the situation using the AA tools. I believe everyone in the room benefitted from this experience. Meetings are where we share our experience, but we are also carrying a message of strength and hope.

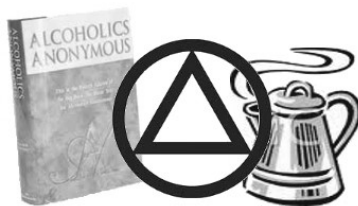

MINUTES – February 2019 minutes on page 6 of the POST; read and approved.

TREASURER'S REPORT – PB presented the Treasurer's Report from page 7 of the POST. Fund balances (expenditures greater than deposits); discussion about pie chart with recommended portions of contributions (WM noted that our IG performs services usually covered by other agencies). Approved.

PHONE COMMITTEE – SR presented; currently no vacancies on the phone grid.

POST – JH reported; no new updates.

LITERATURE & MERCHANDISE/WHERE & WHEN – FS reported that new W&W with date on front (4/19), new Grapevines are in. New volunteers working at the IG office and he invited people to come down and introduce yourselves; MR pointed out page 8 of the POST tells a little about IG and what it provides.

WEBSITE – WM noted that the website is up to date; there are a few future events which have been submitted that will be posted in a timely manner. He is still working on links to addresses. JF asked about "The Meeting Guide" app which he had previously used while out of town, but it is not now working in Gainesville; WM stated that the app links to a database, not our website, and he does not know why it is not now working; GN noted that the app is not yet conference approved.

ACTIVITIES – JH noted Easter activities at both the Primary Purpose Club (on 4/20) and the Triangle Club (on 4/21). SR said that the Meditation Workshop on 3/30 was well attended and well received. WL mentioned the Emotional Sobriety Workshop for 6/21/19 and had 1/4 page flyers for distribution; there should also be a link on the website and you can register online; if you wish to participate, the workshop committee meets on the 3rd Monday, 7:15pm at the Spirit of Truth Church.

DCM – CM reported; DCM Corner on page 9 of the POST; District 14 minutes from 3/13/19 are on page 10 of the POST. Budgets have been approved. Area Assembly will be on 4/5/19 at the World Golf Village in St Augustine; there was a preconference workshop with major topics being safety (calling 911 if necessary), and discussion about a 5th edition of the Big Book.

FCYPAA – ST announced that FCYPAA and the Emotional Sobriety Workshop would be cohosting an ice cream social and silent art auction fundraiser at Gethsemane Lutheran Church on 4/27/19, flyer pending; donations of all art forms accepted.

OLD BUSINESS – No outstanding old business.

NEW BUSINESS – FS announced that the Land Title Plaza where the Intergroup Office is located has been sold, but the future of our lease is uncertain at this time. Page 8 of the POST shows contributions to Intergroup by Faithful Fivers. WL requested a \$200 contribution from Intergroup for the Emotional Sobriety Workshop; WL expects this conference to make a profit and be an annual event; the money would go toward deposits at the hotel and travel expenses for speakers. After discussion regarding the current status of IG finances (needing to raise the prudent reserve and not knowing the status of our lease), the motion was tabled until next month.

There being no further business, motion was made and passed to adjourn

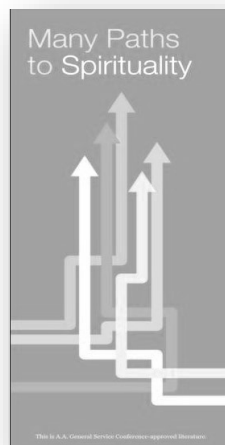

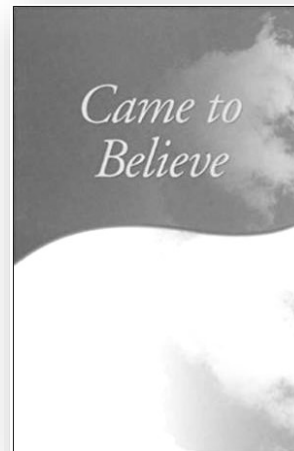

We had a nominal representation from District 14 with only 8 GSRs, 1 Alt GSR and 1 DCM; total of 10 votes. The most represented District at area assembly had a total of 15 votes. I am currently developing a solution to the conundrum caused with attending the women's meetings.
