# Acting My Way Into Right Thinking

I once had a sponsor tell me that you can't just come into AA and jump right into the steps and expect to automatically live a happy life and stay sober. He said that people have to come in and learn how to live like AA's if they want to be AA's themselves. I didn't believe him at first because I saw the steps as other-worldly principles that somehow "work" if you are willing to take them. Over the years, however, I have asked myself more and more: what does it mean to take the steps? They are not just words on a page or words between a sponsor and a sponsee. They were developed out of our early fellowship's collective experience, and I have found that they only work when I put them into real, physical motion.

I attend a lot of literature and step-study meetings, where we "theorize" for hours every week about how the steps are supposed to be taken and what they mean to us. Our Big Book, however, tells us, "The spiritual life is not a theory. We have to live it." It is not enough for me, for example, to text message my ex-wife saying I am sorry for my behavior. I have to go out of my way to be kind and patient toward her on a regular basis for the principles to actually come through in that relationship with any kind of strength. By doing this, I am put into a different state of mind where I can have loving thoughts toward her and other people rather than selfish or resentful ones. My practice therefore has a large impact on my mental state of being. Just like I have to get on a bicycle and fall down a few times before I can learn how to ride one, I have to take the principles I learn about in the AA rooms out into the world and try and fail to apply them repeatedly before I can really learn to practice them well. There has to be a balance between theorizing in the rooms and applying these ideas to my everyday life.

I am an AA member whenever I say so, but I only feel the benefits of being an AA member when I act like one.



# "Made a list of all persons we had harmed, and became willing to make amends to them all."

Many times we hear that this is just making a list of the people to whom we owe amends. To me, it was much more than making a list. It brought up many painful memories. As I looked at my character defects from the Fourth Step, the people I resented, the people I harmed, it brought greater clarity. Clarity which enabled me to grow spiritually. I saw the harm I had done, I desperately wanted to be forgiven. I also still felt I had been harmed. But how could I expect forgiveness, if I was not willing to forgive? As I have heard more than once, if I am not the problem, there is no solution.

Making a list is only the first part of the step. I had to go over the list in detail with my sponsor, as I was not qualified to start making amends on my own. We had to prioritize the list, in fact there were some people who didn't really belong on the list. There were people who would be better off if they never saw me again. In my mind, there were also people to whom I thought I could never and would never make amends.

This brings me to the very important second part of the step, became willing to make amends to them all. The process of working the program, the Steps, brought growth, growth which made me willing to make amends to them all, even myself. For my sponsor had me put myself at the top of my amend list. I was filled with guilt, shame and self-loathing. Obviously, I needed to forgive myself for all the opportunities I had missed, the mistakes I made, the relationships I ruined and the emotional harm I done to myself because of my drinking. For I cannot not regret the past,

I must accept that I was doing the best I could at the time.

And finally, I look at Step Eight as the gift that keeps on giving. The years of sobriety have helped me to remember and understand that there are even more people to whom I owe amends. The Steps are a lifelong journey for me, a journey to happy destiny.

**ATTENDANCE** – GN (Chair), BC (Alt Chair), SR (Secretary), PC (Alt Secretary), PB (Treasurer), MR (Alt Treasurer), FS (Office Mgr), JH (Activities), DO (POST), WM (Webmaster), SL, AM, MN, GM, AT, DL, HG, JH, JM, CH, AO, ST, BK, TL, BM.

MINUTES – SR presented the May minutes on page 6 of the POST; read and approved.

**TREASURER'S REPORT** – PB presented the Treasurer's report on page 7 of the POST. Note at the bottom that contributions are credited for the month they are deposited so contributions received during a given month may not be credited until the following month. Contributions were up for the month (group contributions and Faithful Fivers/Tenners). The negative entry of \$264.76 in the website expenses is due to the fact that the website ownership was paid for a period of six years, and this amount was District's portion for the current period, billed annually.

**PHONE COMMITTEE** – SR reported for SS that there is one vacancy on Sunday from 4-7pm. (This was updated after the meeting to reflect that there is also an opening on Tuesday 7-10pm.)

**POST** – DO reported that the POST is doing well. She reminded everyone to submit upcoming events to Jen H; she also noted that she can help groups with flyers for events.

**LITERATURE & MERCHANDISE/WHERE & WHEN** – FS reported that the Intergroup literature is up-to-date, the new Grapevine topic is "Corrections", and the Intergroup office has Grapevine books on sale for \$7. The W&W is up-to-date as of 6/19/19. The NCFIG website (aagainesville.org) now includes a price list for major publications. Fred is willing to bring orders to the Triangle Club on Sundays as requested by groups. There is now a packet available "Where Money & Spirituality Mix" available.

**WEBSITE** – WM reported that the admin webpage has been completed; it was proofread by M and beta tested. All meetings are now in the database; FS and AO proofread, and NCFIG meetings are now connected to the "Meeting Guide" app (free and approved by WSO). Additionally, there is now a link on the Committees page from which anyone can print out a list of open meetings (which would be useful for CPCPI and other groups interested in learning more about local AA).

**ACTIVITIES** – JH noted several events which are on the back (page 12) of the POST. Of note are the 4<sup>th</sup> of July celebration at the Triangle Club, and the 13<sup>th</sup> Annual Hawthorne Group Picnic on 8/17. The Florida State Convention is 7/31/19; the 7<sup>th</sup> Annual Women In Recovery is 8/16/19; and Serenity by the Sea is 8/23/19; there are links on the webpage.

**DCM REPORT** – The DCM was not in attendance but the District 14 meeting minutes are on page 10 of the POST, and the DCM corner is on page 9. The next Area Assembly is 7/12/19-7/14/19 at the World Golf Village in St Augustine. Accessibilities and Treatment committees are both in need of chairpersons.

**FCYPAA** – ST reported that the State Conference was a wild success with over 1,100 attendees. There will be a disbandment meeting on 7/19/19 at 9:30pm after the Downtown group.

**AL ANON** – No representative; GN noted that they had a table at Founders Day with good information. **OLD BUSINESS** – PC reported that the 1<sup>st</sup> Annual Emotional Sobriety Workshop was a great success; they thank NCFIG and note that they have the seed money they need to have the conference again next year. AO suggested that they might consider having a table next year with literature for sale.

**NEW BUSINESS** – GN reported that FS is working on a pamphlet to inform about NCFIG and it's purpose in this area. It should be ready for review at the next meeting.

Hello District 14!

At the District level all appears to be progressing on track. Corrections is shifting their volunteers around different facilities to best carry the message of AA, Treatment committee is possibly adding several meetings to their already heavy schedule (they will need help covering meetings in August), Accessibilities committee still needs someone to step up as the chairperson, but we are not allowing that to hold us back from carrying the message of AA so we are reaching out to local homeless shelters to help start meetings within those facilities.

Being the DCM for District 14 is an honor and a privilege unlike any I have known in my sobriety. It is a responsibility I take seriously. This past week felt like a perfect example of what being the DCM feels like on a monthly basis. It started off with chairing the Accessibilities committee meeting where several attendees were excited to approach their home groups with the possibility of taking a weekly meeting into a local homeless shelter. Later in the week I meet a former resident of one of these facilities whom having achieved sobriety and stability in their life, wanted to volunteer to go back and share with her former peers how she escaped homelessness. Two days later I was able to attend another struggling committee. The chairperson of this committee wanted to step down due to a lack of participation and being way over worked in their position. I announced the issues this committee was having and had others do likewise. I was expecting the usual 3 people and the chairperson and while they were present and accounted for, there where an additional 20 people in attendance, all of whom offered to step up to be of service. The chairperson was heartened by the support and decided to stay onboard to finish their term and my heart was full. Next up is to chair the monthly committee meeting and at this point I want to step down from being DCM because sleepless nights, problem after problem and unprincipled behavior from sober alcoholics gets real old real fast. Then I remember the alcoholic that was homeless, who is willing to travel to Gainesville from Lake city to share her message of hope with the still suffering alcoholic. I remember all the times I took a meeting into a detox and all of the ways in which being of service has touched my life and the motivation to go to any length is returned. But I cannot do anything by myself.

Bill W. once described as as "a true democracy in that every voice gets heard." I also heard once that the greatest way to protect a democracy is to get involved. So please take a moment after reading this and ask if you, your home group or sponcees can be doing more to carry the message of AA and if you can get involved, please don't over think it, just get involved.
