Staying Away From the First Drink

I was living with my drinking buddy when I got sober, and he did not have a plan to quit. I thought for sure that I would never be able to keep from drinking in the same home I had gotten so sick in, still surrounded by alcohol. The sense of urgency that I felt to create this new life that was laid out before me in Alcoholics Anonymous told me that I had to get out of there right away. However, I also had a very wise and loving sponsor who reminded me of the suggestion "No big changes in the first year." Other women reminded me to keep the focus on myself and on my recovery when I would talk about my fears of being around alcohol at home. It was still a safe place so I listened and stayed put. I worked my program and followed the AA suggestions with everything I had, finishing the steps within six months. To my complete amazement, the program worked and I did not want to drink anymore! I could not believe it. After some time, it did not matter that when I would open the refrigerator I would see my favorite beer because my desire to drink was gone.

At that time, my reality was that I had to go home. I didn't have anywhere else to go and I could not afford my own place to live. One the other hand, I also had experiences in early sobriety where I tried to hang out in old places with friends I used to drink with and ended up leaving in a panic attack, unable to see straight. They were friends that I cared for very much but they were friendships that were rooted in a shared love of enjoying alcohol together. I learned the hard way that my primary reason for being with them in the past had been to drink with them.

"So our rule is not to avoid a place where there is drinking, if we have a legitimate reason for being there." (AA Big Book, pg 101) My understanding is that this quote only applies if the desire to drink has been removed, and the desire to drink

is not promised to be removed until we get to the tenth step.

I truly believe that if I had not worked the steps so promptly with my sponsor after getting to AA and with such desperation, then I would not have been able to stay in that home for a year and a half as I did. I know myself well enough to know that I would have drank that beer and I most likely would not be alive right now.

For me, staying away from the first drink means staying committed to, one day at a time, not picking one up. It was a decision I made when I got here and a decision I continue to make every single day. It is always an option, but I know that with the tools of the program, the fellowship and my Higher Power, I never have to drink again for the rest of my life if I do not want to. —Anonymous

"Alcoholics Anonymous has no opinion on outside issues; hence the A.A. name ought never be drawn into public controversy."

When asked to write about Tradition 10, I could think of many who could do a much better job than I, but I had been taught by the "Old Timers" that there is one answer when asked to do something and that was "Yes, I'd be honored." I feel I have been of the "Educational" variety when learning the Traditions. However, I do feel I've learned more by making mistakes and learning what NOT to do. I'm sure I have crossed lines when working in treatment, although I was hired specifically to teach the clients the 12 Steps. I was convinced when getting sober that Alcoholics Anonymous was the ONLY way to get and stay sober. In fact, they certainly would not make it if they did not do "it" our way. I would preach that from the roof tops and argue with others. I took to trying to save the poor lost souls and told them of my membership to AA and they too could be one of the "chosen" ones if they'd only do as we did, or at least as I did. Unfortunately, I put Alcoholics Anonymous reputation on the line when I would be spiritually unfit and act like a jerk. And as I would learn much later, there are many people who have found other means to stay sober without AA. I just don't happen to be one of them!

There has been no better time than now that I am grateful for the Traditions in such a heated political environment because one thing I am sure of is the disease of alcoholism has one primary job and that is to separate and divide us. If we did not have them, it would definitely win and we would be left to perish as we did in the days before Alcoholics Anonymous. We really do have a common peril that glues us together in the most trying of times and also times of which we need each other the most. We must remember we have been here before and it is the Language of the Heart that will continue to save us if we don't let our fear and egos destroy us.

Lastly, I know from being a member for some time now, that the word "God" has probably made more people revolt than any other term when coming to AA. I was one of those people. However, I begged "Whoever" was out there to help me, as many of us did and I am eternally grateful as I have heard many of you are, that I was given a choice and that I did not have to defend my beliefs or non beliefs to be a part of such a magnificent entity. I am so grateful that Tradition 10 reminds me to offer that safety net for the people coming in and that we are all One in the Spirit of the Universe.

Step 10

"Continued to take personal inventory and when we were wrong promptly admitted it ."

Depending on if your opinion of Step 10 lies in the Big Book or the 12 & 12, you may receive a different message. Personally, I prefer the Big Book's description, because why would I want to hang onto something all day when it can be taken care of immediately? If I remove my garbage promptly, then my house won't stink!

In the Big Book's description of the 10th step, it tells us that **when** our character defects crop up, not if, not before bed, and not when we feel like it, we can ask our higher power to remove them, discuss them with another person immediately, make amends, and see where we can be of service. When I started to practice the 10th step instead of calling my sponsor to complain and asking to repeat my 4th and 5th step inventory, life suddenly became much more serene and peaceful.

The 10th step also makes us one of the best promises of all: "We are not cured of alcoholism. What we really have is a daily reprieve contingent on the maintenance of our spiritual condition." For those of you who don't have a dictionary handy, it states we will be spared the misery of alcoholism depending on whether or not we take care of ourselves spiritually *every day*. That promise is the reason I found myself in the rooms of AA, and the motivation that encourages me to continue to work my program. -Lindsay M

AUGUST 30, 2020

ATTENDANCE – GN (Chair), BC (Alt Chair), JW (Secretary), PC (Alt Secretary), PB (Treasurer), MR (Alt Treas), FS (Office Mgr), WM (Webmaster), TS (POST), AO, TC, JH, NF, JF, and HZ, and two others (17 people) in attendance.

MINUTES – JW presented the July meeting minutes (page 7 of the POST). Minutes were approved. JW thanked WM for the addition to the website encouraging involvement by groups to report new or changing representatives so our roster can be updated.

TREASURER'S REPORT – PB presented the July treasurer's report (page 8 of the POST). Group contributions are up from prior months. The Office Manager's salary includes second quarter taxes. Any reserve funds borrowed were repaid within the month and Faithful Fivers contributions added to reserve cash funds. Website fees show a credit due to reimbursement made to Intergroup by District. The report was accepted unanimously.

PHONE COMMITTEE – Chair could not attend, but did send request for volunteers to fill 2 openings (Sundays 8 am – Noon & Tuesdays 5 pm – 7 pm).

POST – TS reported and apologized for printing error that was corrected in the online version, but not before the hard copy POST had been run by the printer. GN noted that the error was hardly noticeable. TS has been doing a great job with the POST.

LITERATURE & MERCHANDISE/WHERE & WHEN – FS reported that the office is open except for Mondays. A volunteer for Mondays is welcomed and training will be provided, if needed. Where & Whens are printed 300 at a time. With the exception of meetings switching to Zoom format during COVID-19 conditions in March, there have been only a few changes to meeting schedules so reprinting will wait until more of the current supply is sold.

WEBSITE – WM reported that an area was added to the webpage for reporting of birthdays. The list of meetings is easier to locate through updated link and public service announcements were added. WM has developed and maintained our website for 10 years so he reached out for a volunteer who might be interested in working and training with him to assist if needed on the technical aspects of the website. No specific time was identified for turning over responsibilities to another volunteer, but it would be a good idea to have a backup or assistant webmaster to learn the ropes. Qualifications for this will be posted on the website.

ACTIVITES – Chair not present. It was announced that the locale anticipated for holding a joint Founders Day / Gratitude Dinner in November will not be available due to continuing COVID-10 conditions. An outdoor venue will be considered but it may not be possible to hold this event until the next year.

DCM REPORT - Not present; no meeting was held last month. Elections are due to be held in November.

OLD BUSINESS - The Bylaws were amended for all officer and alternate elections to be held once a year in December.

NEW BUSINESS – A discussion was held on whether it is preferred for the POST to report attendees at Intergroup meetings using initials only or first name and last initial. Due to ongoing limited in-person meetings held, some preferred for AA members to be able to clearly identify their representative having attended our meeting. Others were concerned about upholding the principle of anonymity and any potential risk to that principle due to the unrestricted accessibility of the POST on our website. No specific motion was made and the topic may be discussed, if needed at another meeting.

Discussion was held on redirecting "Instant AA" online visitors to our website. A Motion was made and seconded, but not voted upon. It was pointed out that our homepage may not be as complete as Instant AA and there are a few Instant AA meetings that are not necessarily registered groups. It was preferable to have WM (our webmaster) and JF (on behalf of Instant AA) to confer about what would need to be done to simplify, link, or combine communications between the two. A motion was made, seconded, and unanimously approved to table this idea for further discussion at the next meeting.

There being no further business, the meeting was closed with the Responsibility Pledge.

The next Intergroup Business meeting will be held at 1:00 the last Sunday of the Month.
