When I think of willingness, I immediately think of Step 6. I didn't realize how much willingness I had shown early in my recovery until I worked Step 6 with my first sponsor. He reminded me that I had been willing many times when I first got sober, starting with that last night (hopefully) that I spent in jail for my third DUI. When the intake officer asked me if I thought I had a drinking problem (no kidding?), I finally said "yes". After 20 straight years of denying that fact, I guess I was beaten into willingness (and honesty) at that point.

Out of that one admission of powerlessness, continuing acts of willingness started to occur! I became willing to face the many consequences of my actions, which included going to AA meetings and getting into treatment for 60 days. That was the beginning of my relationship with a higher power. And then it was suggested that I pray for willingness when my old defiant ways came back. I tried to do what was suggested to me, mainly by the counselors at the treatment center who were AA members also. After getting out of treatment, I went to three meetings a day, and was willing to ask for rides from people. Three DUI's, and you don't drive for a while!

Along the way, my higher power kept granting me willingness to do the next right thing. I had seen the benefits of prayer in treatment, and continued praying every day. I was feeling better, and the habits I formed in treatment were starting to take hold. I got a sponsor, and he talked a lot about "being willing" to do things, even if I didn't want to do them. That still is true today. Entirely ready for me is going to the "any lengths" that they talk about in the Big Book. Any lengths for me is going to meetings, meeting with sponsees and my sponsor, reading the literature, and doing service work. All while not always wanting to do these things.

I've seen many people stop doing the things that got them sober, and bad things happened. This happened to my first sponsor. He wasn't willing to continue doing all the things he had been doing, and he went back out with 12 years sober. That may have been the best lesson he taught me! Because whenever I'm not wanting to do something for my sobriety, I think of him and pray for willingness. I do what I may not want to do, because I don't want to chance what could happen if I stop! -Greg N.

The Steps are HOW IT WORKS. The Traditions are <u>WHY IT WORKS</u>.

"Each group has but one primary purpose: to carry its message to the alcoholic who still suffers."

Tradition five in simple terms states our singleness of purpose. To carry the message which was freely given to us. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose — that of carrying its message to the alcoholic who still suffers.

The main purpose of an AA group is to share experience, strength and hope to the still suffering alcoholic. In my own personal experience, I am very grateful that I heard the great message of recovery at my first home group meeting. I am convinced I would not have come back if all I heard was a constant share about drinking and not the solution. For that night I didn't just hear one message there was a unified message by ALL group members. That was the key for me to keep coming back.... the message!

At my Homegroup, meetings are run like a well-oiled machine because the group understands the importance of Tradition 5, when a member shares they share for the alcoholic who still suffers not always solely the newcomer. Whenever I am asked to share, I always remember how I felt walking through the doors the very first time and how anxious, nervous I was and full of fear. When the meeting started I heard some amazing shares the message was loud and clear. So I always think of the nervous newcomer and hopefully try and carry a message of recovery to give them hope that there is a solution to their alcoholism.

Doing service and my home group has been an honour and another example of Tradition 5 in action. I absolutely loved the service position of "greeter", being the very first point of contact to the newcomer, a big smile and a handshake to help put them at ease. Even if I had a terrible day at work, where all things went wrong, I would simply "suit up and smile" regardless of how I felt. By the end of the service I would feel amazing, because I was thinking of others and not myself. My service position as secretary is a bit like a conductor at an orchestra to ensureall the elements are running like clockwork. In the preamble we always have a moment's silence to remember Tradition 5. During the shares from the floor I will promptly ring the bell if discussion of "Problems other than alcoholism" are dwelled on. This is not helpful for the newcomer, they need to hear that "sobriety, freedom from alcohol through the teaching and practice of the twelve steps" is possible.

Tradition 5 allows me to stay sober. I wouldn't be able to maintain sobriety if I didn't give it away. How can I continue to work the Steps and the program of AA and NOT pass this amazing message on? -Rhi A

Self-support: Where money and spirituality mix!

Step 5 "Admitted to God, to ourselves, and to another human being the exact nature of our wrongs."

Completing my first fourth step weighed very heavily on me. I had never taken such an honest look at the relationships that had shaped me into who I was. Self-reflection was something I had enjoyed in my teens, but as fear and shame wore me down and destroyed my self-esteem over the years I found it unbearable to even look at myself in the mirror, let alone on paper. Thankfully I was desperate for Alcoholics Anonymous to work in my life the way I saw it working for so many others, so I started on my fourth step as soon as it was suggested to me and finished it within a couple of weeks.

However, simply putting my inventory down in writing did not really help me much on its own. I was still alone with my hidden resentments towards others and myself. I was still looking at the most painful experiences of my life through a lens of self-centeredness and shame.

Everything took a pretty incredible turn during my fifth step meeting with my sponsor. She was someone that I felt very safe with. I trusted that I could be completely honest with her and that she would not think any differently of me no matter what I said. She opened up her home for us to meet. It felt even safer to me than my own home did at the time.

As I sat there with her and disclosed everything I had written, I was set free. The memories were still with me, and they no longer owned me. I remember staring at the first column words on the pages and thinking, "Wow, they are so small and insignificant." Things that had taken up so much space in my mind for so long were finally put into their proper perspective. It was only the beginning of what has been a long road of learning how to forgive, trust and let go, but that initial fifth step was an essential block in the foundation of my recovery. As I am now celebrating eight years of sobriety and have shared multiple fifth steps with trusted women, I am able to look back and clearly see how much I was transformed by those early days of my sobriety because of my determination and willingness to put in the work.

March 28, 2021

Opening – BC Chair, opened the meeting with a moment of silence and the Serenity Prayer at 1:00 PM.

IG Reps: JH (New Life Group); MC (Gratitude Group); PC (Women's Serenity Seekers). Guest/s: CO (Eye Opener Group).

Alt I/G Chair: GN welcomed all new I/G reps. Announced a candidate will stand for this position in New Business.

Secretary Report – DK: Minutes of the Feb. 28, 2021 meeting (see April POST) were accepted. Motion by MC 2nd by NL

Passed unanimously.

Treasurer Report – PB: The Feb 2021 Report (see April POST) was approved. The Office Reserve fund total increased to \$2,500 from \$2,180.90. Monthly expenses included \$168.83 for literature and \$1,268.95 for overhead. Group contributions were \$1,204; down \$88 from Jan. Faithful Fivers and Tenners donated \$49.00, down \$240 from Jan. Motion by PC; 2nd by NL. Passed unanimously.

Phone Committee – BC for SS reported that there are currently 2 openings: Thursdays from 9 PM to Fridays at 7 AM; and Sundays from 10 PM to Mondays 7 AM. These positions were two of three open last month.

POST - TS: Not present. Note: The April POST is published on the website.

Intergroup Office – FS said printing of next Where & When is planned for summer. He urged each group to update info.

Website -NL (Alt Webmaster) noted the website is up to date except for information from some new committees.

Activities - JH: Not present. Note: Activity flyers are posted on the website.

D14 DCM Report – Kris P (Alt DCM): 1) All officer and committee chair positions are filled. 2) Monthly meetings will continue on Zoom on the second Wednesday of every month, at 6 PM. Follow Zoom link on www.aagainesville.org. 3) The FY 2021 budget has been approved. Committee budgets remained the same. 4) The next Area Assembly will be held via Zoom on Fri., April 9th – Sun., April 11th. Links to the Assembly are available on the www.aagainesville.org and www.aanorthflorida.org websites; and 5) GN congratulated NL on her election to the D14 Website Chair position.

MC sobriety date is in April 2015 and he has service experience at the home group, district and FCYPAA levels. MC was elected by unanimous vote. 3) MM announced he is moving from Gainesville and at most, he can host one more Zoom meeting. He noted the \$14.99/month account fee is reimbursed by I/G office. In response, KP volunteered to host future I/G meetings until a permanent host is found; and 4) DK noted that she announced her intent to purge the I/G email address list following responses to today's meeting reminders. BC and KP encouraged collaboration with D14 in this effort. D14 Officers and Committee Chairs' emails will be added to the updated I/G list and vice versa.

BC closed the meeting at 1:37 (Motion by NL; 2nd JH) with the Responsibility Declaration.

of email distribution lists.

Corrections – BB said the committee met in person on Feb. 15th. He stated that the POST meeting information is correct, that the committee meets on the 3rd Tuesday of every month, at 6:00 PM, at the Triangle Club.

The Alachua County jail and the Gainesville Work Camp men's meetings are now active.

CPC/PI – CQ reported the committee will meet on March 18th, via Zoom. He is to provide the Zoom meeting ID and PW to KP, Area 14 CPC/PI Service Coordinator, the D14/Intergroup Webmaster; and the POST.

Interested members are encouraged to contact CQ at cqualmann@gmail.com. Additionally, CQ requested purchasing and reimbursement guidance. The protocol is for committee chairs to submit expense descriptions with

receipts to the D14 treasurer. Approval of the DCM is prerequisite to Treasurer issuing a check for reimbursement. **Grapevine** – Position vacant.


Faithful Fiver

A Link between your Home Group and District 14's Intergroup

What is an Intergroup Rep?

The Intergroup Representative is your Home Group's voice for assuring that your Intergroup Service Office functions and carries out its Primary Purpose. All AA groups are welcome to participate at Intergroup.

What is the Primary Purpose of Intergroup?

Our main purpose is to help alcoholics find AA meetings and assist newcomers in the recovery program of Alcoholics Anonymous. Intergroup's VITAL SERVICES

- 1. We answer our Telephone Hotline Service 24 hours a day to assist new members with the help and hope of AA
- 2. We stock all AA Conference-approved literature and other books for the AA community
- 3. We maintain an office to facilitate 12 Step calls and service opportunities
- 4. We maintain a web-based meeting directory which is updated weekly at *aagainesville.org*
- 5. We publish a print meeting directory at least once annually
- 6. We publish the Post newsletter every month

7. We respond to inquiries from outside agencies, including the media, seeking information about the Fellowship of Alcoholics Anonymous

How does someone become an Intergroup Rep?

All AA groups are eligible for membership. Groups elect an Intergroup Representative and an Alternate Representative; they usually serve a 2 year term. Each Group determines length of sobriety for their Representative however experience has shown that at least 2 years is ideal.

What does an Intergroup Rep do?

Intergroup Reps and Alternate Reps attend the monthly Intergroup Representatives' Meeting. These 'Reps Meetings' are held 12 times per year on the last Sunday of every month unless it falls on a Holiday. Intergroup Reps are responsible for two-way communication between their Home Group and Intergroup. Advise the group treasurer of where the 7th Tradition funds should go after the group's expenses are met. It is also important that your group have a primary contact, that we may remain in contact with. Make sure that your Home-group's information is correct on the hard-copy meeting schedule, and the website at aagainesville.org.

What are Intergroup Rep meetings like?

Representatives register with Intergroup at each Reps Meeting by providing their contact information and home group. Each Rep and home group is responsible for providing the office with current contact information to insure that AA group members have the opportunity to participate in Intergroup's 12 Step Services.
