

I always have enough food, clothes, shelter, material goods, love, friends, etc. In fact, now that I spend more time in the present I am finding that somehow, mysteriously, God actually provides an abundance of everything I could possibly need with plenty left over to share. My job now is to simply stay sober, stay present, pay attention, and try to be a good steward of the many gifts in my life.

So there's irony in this new way of simple living: what used to look like a highly complex and complicated *full plate* turns out to be, in reality, an effortless existence based only on the needs and provisions of this day, the present.

Way too simple! Absolutely unsophisticated! All of a sudden my life is framed in "what do I need to do by midnight tonight?" My impressive list of possible accomplishments is now reduced to a half dozen lackluster daily necessities. It occurs to me that when we pray "give us this day our daily bread" it refers to what supplies we might need for today, knowing and trusting that God will do the same for us tomorrow as he has for countless days previously.

It looks like my busy schedule just got freed up! Thanks once more to the Grace of God, the chaos and drama of my everyday life, real or perceived, has been managed for me. Yet another opportunity for surrender!

Tradition 8 The Steps are HOW IT WORKS. The Traditions are WHY IT WORKS.

"Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers. "

Throughout the world AAs are twelfth-stepping with thousands of new prospects a month. Between one and two thousand of these sick on our first presentation; past experience shows that most of the remainder will come back to us later on. Almost entirely unorganized and completely non professional, this mighty spiritual current is now flowing from alcoholics who are well to those who are sick. One alcoholic talking to another; that's all.

Could this vast and vital face-to-face effort ever be professionalized or even organized? Most emphatically, it could not. The few efforts to professionalized straight twelfth Step work have always failed quickly. Today, no AA will tolerate the idea of paid "AA therapists" or "organizers." Nor does any AA like to be told just how he must handle that new prospect of his. No, this great life-giving stream can never be dammed up by paid do-gooders or professionals. Alcoholics Anonymous is never going to cut its own lifelines. To a man, we are sure of that.

But what about those who serve us full time in other capacities — are cooks, caretakers, and paid intergroup secretaries "AA professionals"?

Because our thinking about these people is still unclear, we often feel and act as though they were such. The impression of professionalism subtly attaches to them, so we frequently hear they are "making money out of AA" or that they are "professionalizing" AA. Seemingly, if they do take our AA dollars they don't quite belong with us AAs anymore. We sometimes go further; we underpay them on the theory they ought to be glad to "cook" for AA cheap.

Now isn't this carrying our fears of professionalism rather far? If these fears ever got too strong, none but a saint or an incompetent could work for Alcoholics Anonymous. Our supply of saints being quite small, we would certainly wind up with less competent workers than we need.

We are beginning to see that our few paid workers are performing only those service tasks that our volunteers cannot consistently handle. Primarily these folks are not doing Twelfth Step work. They are just making more and better Twelfth Step work possible. Secretaries at their desks are valuable points of contact, information, and public relations. That is what they are paid for, and nothing else. They help carry the good news of AA to the outside world and bring our prospects face to face with us. That's not "AA therapy"; it's just a lot of very necessary but often thankless work.

So, where needed, let's revise our attitude toward those who labor at our special services. Let us treat them as AA associated, and not as hired help; let's recompense them fairly and, above all, let's absolve them from the label of professionalism.

Let us also distinguish clearly between "organizing the AA movement" and setting up, in a reasonably businesslike manner, its few essential services of contact and propagation. Once we do that, all will be well. The million or so fellow alcoholics who are still sick will then continue to get the break we sixty thousand AAs have already had. -Copyright © The A.A. 

Self-support: Where money and spirituality mix!

Step 8 "Made a list of all persons we had harmed, and became willing to make amends to them all."

Asking for forgiveness is a cleansing act which is humbling and necessary for our spiritual progress and sobriety. By asking for forgiveness, we certainly do not change the past; at best, it may open the door for a future relationship to flourish. However, what we can count on as certain is that these acts of contrition release us from our own imprisonment. The chains of resentment and shame are broken and we experience a freedom as never known before. So, as we look at the wreckage of our past, clearly staring back at us from Step 4, we begin to compile a thorough list of people (and institutions) we have harmed to whom we are willing to make amends.

The operative word is "willing". One of the barriers to my willingness was that some of those on my list deserved the pain I inflicted on them because they hurt me first. I soon learned that justifiable anger is like a weed which must be eradicated by its roots. Pruning did not do the trick; I tried cognitive restructuring, self-talk, denial, and rationalization. This "justifiable anger" sprouted everywhere until I felt my newly acquired life force strangulated. Finally, I surrendered. My Higher Power had to take this negativity away and replace it with love and compassion towards those I resisted in making amends. I had to forgive first before I could genuinely make amends. The third step prayer became my mantra.

I realized through the process of the eighth step that I was letting go; setting free those in my amend list, but soon I realized I was the prisoner and I had been set free.

Treasurer Report – PB: May Sales totaled \$1,348.60. Group and individual contributions totaled \$872.00. Purchases were \$414.05. Overhead expenses were \$1,356.01. Activities and committees had no expenses. Ending checking account balance was \$3,579.30. Available reserves include \$3,500 for Gratitude Dinner; and \$2,500 for office expenses. Office reserves in CD's total \$11,097.27, but these have matured and either have been or will be cashed out and deposited in the operating account. The May 2021 Treasurer's Report (see July P.O.S.T.) was approved as reported. Motion by Greg N. 2nd by MR. Passed unanimously.

Phone Committee – BC reported for SS: All positions for the AA Hotline are currently filled. [Editor's note: Except for alternating Thursdays from 9PM – Fridays 7AM).

P.O.S.T. – TS: No report, but FS noted that hard copies of the newsletter were not available in time for this meeting.

Intergroup Office - FS posted the 2nd Quarter Financial Report in the July P.O.S.T. At the end of the first six months of 2021, Intergroup saw a net profit of \$339.00. He also noted that hard copies of the Where & When are available at the office.

Website - WM (Webmaster): No report.

Activities – JH: Fred noted that flyers are posted on the website.

The Intergroup Representative

A Link between your Home Group and District 14's Intergroup

What is an Intergroup Rep?

The Intergroup Representative is your Home Group's voice for assuring that your Intergroup Service Office functions and carries out its Primary Purpose. All AA groups are welcome to participate at Intergroup.

What is the Primary Purpose of Intergroup?

Our main purpose is to help alcoholics find AA meetings and assist newcomers in the recovery program of Alcoholics Anonymous. Intergroup's VITAL SERVICES

- 1. We answer our Telephone Hotline Service 24 hours a day to assist new members with the help and hope of AA
- 2. We stock all AA Conference-approved literature and other books for the AA community
- 3. We maintain an office to facilitate 12 Step calls and service opportunities
- 4. We maintain a web-based meeting directory which is updated weekly at *aagainesville.org*
- 5. We publish a print meeting directory at least once annually
- 6. We publish the Post newsletter every month
- 7. We respond to inquiries from outside agencies, including the media, seeking information about the Fellowship of Alcoholics Anonymous

How does someone become an Intergroup Rep?

All AA groups are eligible for membership. Groups elect an Intergroup Representative and an Alternate Representative; they usually serve a 2 year term. Each Group determines length of sobriety for their Representative however experience has shown that at least 2 years is ideal.

What does an Intergroup Rep do?

Intergroup Reps and Alternate Reps attend the monthly Intergroup Representatives' Meeting. These 'Reps Meetings' are held 12 times per year on the last Sunday of every month unless it falls on a Holiday. Intergroup Reps are responsible for two-way communication between their Home Group and Intergroup. Advise the group treasurer of where the 7th Tradition funds should go after the group's expenses are met. It is also important that your group have a primary contact, that we may remain in contact with. Make sure that your Homegroup's information is correct on the hard-copy meeting schedule, and the website at aagaines-ville.org.

What are Intergroup Rep meetings like?

Representatives register with Intergroup at each Reps Meeting by providing their contact information and home group. Each Rep and home group is responsible for providing the office with current contact information to insure that AA group members have the opportunity to participate in Intergroup's 12 Step Services.
