Looking back, I can see that God's hand was on my life from the very beginning. Not because everything worked out or because there was a happy ending. On the contrary, things were so difficult that at one time I figured if there was a God that he was torturing me or must not like me very much. In fact, forces beyond my control were orchestrating a series of events that have led me right here to this very moment. A series of events that no matter how hard I tried to evade, or how persistently I applied myself to sabotaging them, I could not. God brought me right to where I didn't even know I wanted to be. He has leveraged all of the very things I thought were proof that He did not exist, or was mad at me, into the strongest evidence I have that He exists and loves me beyond my comprehension. He has turned these very things into my most valuable tools for helping others. All that was necessary on my part was to take some simple actions, acquire a new attitude, and utterly surrender it all to Him. The amazing part about it to me is how relentlessly He pursued me while I ran in the opposite direction. Today I walk on faith that if it was true then, then it is true now. If He made a way for me where there was no way, then He can do it again. I believe I can trust God, even when I do not understand what is happening or why. Even when I do not like my circumstances, or they bring me great pain. The story of my journey into recovery is not one of me "reaching the bottom" where I finally "learned my lesson" and decided to "just stay sober no matter what!" My story is that I drifted ashore beaten, defeated, and totally deflated. I knew that I must remain totally sober, but I also knew that no matter how hard I tried, I just wouldn't be able to. When I crashed and burned (and it wasn't the first time) the veil of my insanity was temporarily lifted, and I was granted a window of opportunity. My family never stopped praying for me and loving me the best - pg. 97 BB. they possibly could, and when I conceded they were ready to help me get help. While the window was open, I was taken to detox (not my first one), where I met a man who convinced me to come to a rehab (again not my first one).

experience to me. Because of this, I too wanted to take these "steps" I had heard about in so many meetings. So, I met a man who showed me what he had done with his sponsor. And that man had done the same with his sponsor! We opened our society's basic text, the "Big Book" of Alcoholics Anonymous, followed the instructions word for word, and a miracle happened. One that I obviously can not take credit for because I didn't even know it was happening until it had! I needed only to muster up enough willingness and honesty to take these simple steps. That is why when I think of where I was, and where I am now, I think much less of how proud I am of myself and much more of how thankful I am to God and all those who helped me along the way.

The 12 steps are filled with promise. They promise us a spiritual experience and to connect us to The Power which can save our lives! We never finish the steps; it is a way of life. Their effectiveness is in direct correlation to my action. There is no single action that I can take which will be more effective in keeping me sober than showing another alcoholic that we have a solution and how to take these steps. If I have the capacity to take my body to the fellowship, take my mind to the steps, and take my spirit into service... I can and will remain

Today God's whispers guide me if I'll listen. His direction has never led me astray and His promises ring true always. He has never let me down, no matter how many times I have failed. He has been with me in my darkest moments, His love knows no bounds, and none of this would be possible without Him. Words cannot express how grateful I am.

Tradition 11

The Steps are HOW IT WORKS.
The Traditions are **WHY IT WORKS**.

"Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films."

Providence has been looking after the public relations of Alcoholics Anonymous. It can scarcely have been otherwise. Though we are more than a dozen years old, hardly a syllable of criticism or ridicule has ever been spoken of A.A. Somehow we have been spared all the pains of medical or religious controversy and we have good friends both wet and dry, right and left. Like most societies, we are sometimes scandalous – but never yet in public. From all over the world, naught comes but keen sympathy and downright admiration. Our friends of the press and radio have outdone themselves. Anyone can see that we are in a fair way to be spoiled. Our reputation is already so much better than our actual character!

Surely these phenomenal blessings must have a deep purpose. Who doubts that this purpose wishes to let every alcoholic in the world know that AA is truly for him, can he only want his liberation enough. Hence, our messages through public channels have never been seriously discolored, nor has the searing breath of prejudice ever issued from anywhere.

Good public relations are AA lifelines reaching out to the alcoholic who still does not know us. For years to come, our growth is sure to depend upon the strength and number of these lifelines. One serious public relations calamity could always turn thousands away from us to perish – a matter of life and death indeed!

The future poses no greater problem or challenge to AA than how best to preserve a friendly and vital relation to all the world about us. Success will rest heavily upon right principles, a wise vigilance, and the deepest personal responsibility on the part of every one of us. Nothing less will do. Else our brother may again turn his face to the wall because we did not care enough.

So the Eleventh Tradition stands sentinel over the lifelines, announcing that there is no need for self-praise, that it is better to let our friends recommend us, and that our whole public relations policy, contrary to usual customs, should be based upon the principle of attraction rather than promotion. Shot-in-the-arm methods are not for us — no press agents, no promotional devices, no big names. The hazards are too great. Immediate results will always be illusive because easy shortcuts to notoriety can generate permanent and smothering liabilities.

More and more, therefore, are we emphasizing the principle of personal anonymity as it applies to our public relations. We ask of each other the highest degree of personal responsibility in this respect. As a movement we have been, before now, tempted to exploit the names of our well-known public characters. We have rationalized that other societies, even the best, do the same. As individuals, we have sometimes believed that the public use of our names could demonstrate our personal courage in the face of stigma, so lending power and conviction to news stories and magazine articles.

But these are not the allures they once were. Vividly, we are becoming aware that no member ought to describe himself in full view of the general public as an AA, even for the most worthy purpose, lest a perilous precedent be set which would tempt others to do likewise for purposes not so worthy.

We see that on breaking anonymity by press, radio, or picture, any one of us could easily transfer the valuable name of Alcoholics Anonymous over onto any enterprise or into the midst of any controversy. So it is becoming our code that there are things that no AA ever does, lest he divert AA from its sole purpose and injure our public relations. And thereby the chances of those sick ones yet to come.

To the million alcoholics who have not yet heard our AA story, we should ever say, "Greetings and welcome. Be assured that we shall never weaken the lifelines which we float out to you. In our public relations, we shall, God willing, keep the faith."

Self-support: Where money and spirituality mix!



"Sought through prayer and meditation to improve our conscious contact with God, as we understood Him, praying only for knowledge of His will for us and the power to carry that out."

Cultivating an active relationship with the God of my understanding has been an awkward yet delightful process. It first began after I started working the steps with a sponsor in AA and he removed my desire to drink and use. I had been absolutely obsessed with numbing myself with substances for over fifteen years, and when the craving quickly disappeared following my initial surrender, I could not believe it. I knew something like this would take a miracle, but I did not believe in miracles, so I was convinced that I was doomed to die. Once the problem was gone, I felt as if God was speaking to me in a very clear and personal way, saying "I am here. You can trust me, and I love you." The fact that the obsession has not returned in more than eight years continues to amaze me every day. I've also had a myriad of other events occur which give me a reason to believe that God is always present and speaking to my spirit.

When I first started working the steps, I practiced Step 11 quite simply because I wanted to stay sober even though it made me very uncomfortable. Over time, because of the innumerable amount of spiritual shifts I have experienced in sobriety, both slight

and substantial, I have developed a strong desire to spend time with God; thanking him, sitting in silence with him, dancing for him, singing to him, writing to him, praying out loud to him on my knees with my arms raised, including him in my exercise routines and asking him to lend me some of his strength, going on bike rides with him, travelling on new adventures alone with him, walking or swimming through nature with him while taking pleasure in his wonders, driving with the windows down and feeling his wind move through my hair and all around me, laying in the grass and staring up at his beautiful blue sky through his trees while his sun warms my skin, and at times screaming at him in tears. I feel like every one of these actions bring me just an inch closer to him, and his existence in my life remains unquestionable. I try to be intentional about inviting him into each thing I do. Ten years ago, the idea of God meant almost nothing to me. Since he has reconstructed my entire life and I have consistently made spending time with him a priority, he is as tangible to me as a real-life person sitting right in front of me. This is my greatest joy of being and a beautiful surprise that I was not expecting when I joined AA to avoid my certain death. -TS


