

## OUR COMMON WELFARE should come first

When I crawled into AA in 1980 I was in very bad shape. By the end of my drinking I had reached that point of incomprehensible demoralization so clearly described in our literature.

Somehow in the midst of my despair I found AA, stumbled into my first meeting, and realized that the answer to my life's problem was in the rooms of Alcoholics Anonymous. I also knew with absolute certainty that AA was the last house on the block for me. If I was to live I needed to remain sober in Alcoholics Anonymous.

One day when I was still very new I attended a meeting at which a speaker explained the 12 traditions of AA. As I sat at that meeting, still so sick, so broken, so very close to the despair that haunted me toward the end of my drinking, I realized that if it were not for the 12 traditions of Alcoholics Anonymous, AA would not exist. Since my life depends on AA, from that moment until this moment I have believed that the 12 traditions of Alcoholics Anonymous are as important, as vital, as the 12 steps of Alcoholics Anonymous.

Like every other adult person I know, I have been affected by the deep political divisions that exist in our country. Sometimes I have felt very angry, and at times it has been difficult for me to exercise restraint of tongue and pen.

However, I do believe in my deepest being that it is of vital importance to the survival of Alcoholics Anonymous that I not discuss or argue political topics at AA meetings on any level, and so I do not discuss or argue them.

(The following quotes are from the AA preamble and from the books Alcoholics Anonymous and Twelve Steps and Twelve Traditions.)

*"AA is not allied with any...politics...neither endorses nor opposes any causes."*

*"We must avoid quick-tempered criticism and furious, power-driven argument."*

*"Tradition One: Our common welfare should come first; personal recovery depends upon AA unity."*

*"The unity of Alcoholics Anonymous is the most cherished quality our society has. Our lives, the lives of all to come, depend squarely upon it."*

*"Realization dawns...that no personal sacrifice is too great for preservation of the Fellowship...the clamor of desires and ambitions...must be silenced whenever these could damage the group. It becomes plain that the group must survive or the individual will not."*

*"Tradition Ten: Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy."*

I still believe, as I did at my first tradition meeting years ago, that the 12 traditions are of vital importance. I MUST adhere to them if I hope that Alcoholics Anonymous will continue to exist in my life and in the lives of alcoholics yet unborn, and for that I am responsible. –SS

***“The only requirement for A.A. membership is a desire to stop drinking.”***

I believe Tradition Three is the reason AA has survived and thrives today. I believe it is the reason I and many other alcoholics are alive today. The early AAs were very fearful that the wrong kind of member might spoil or ruin AA because the organization was so new and they understood their lives depended upon the existence of AA. Thus each AA group put many restrictions on about who was allowed to join. They did not want to be associated with undesirables who would give AA a bad reputation, they were respectable alcoholics. It seems difficult to believe now. Eventually the he restrictions began to be lifted after the first “drug addict” and the first “non-believer” were admitted. Both these men proved to be great AAs who helped many people during their recovery.

I am a member of AA because I say I am a member. I was dying when I came to AA. What if I had been told women weren’t allowed, old people couldn’t join, Northerners weren’t welcome, Catholics weren’t allowed, and I talked too much. Thank God none of that happened. I was welcomed with open arms. No one said “you haven’t hit your bottom yet.” I had found my tribe, a family who understood me better than my family of origin. I am forever grateful.

Now I must give what was given freely to me. I actively welcome all new members. It doesn’t matter who they are, where they came from, we do not discuss their religion, their politics. These issues are irrelevant in AA. I only need to know that this person is another suffering alcoholic like me. I reach out my hand and say Welcome to AA, I’m...

# Step 3

***“Made a decision to turn our will and our lives over to the care of God as we understood Him.”***

Oh no! What does this mean? Am I going to be consigned to being some kind of goodie two shoes, some Pollyanna? One of those people that make the top of your mouth tingle because they are so sweet? Absolutely not! Step Three is a logical step and is the culmination of the first two steps. Step One brought me to the realization of my need for God as a result of my powerlessness and my unmanageable spirit. It showed me that I have no control once I put any mood-altering chemicals in my body and how I have lost the power of choice in alcohol and drugs and do not have the needed power to stop and stay stopped. Step Two gave me the solution to my problem—the need for a Power greater than myself. It gave me a direction to go in—to have a willingness to believe there is a Power greater than myself and to create my own conception of this Power. It helped me understand that this Power is all or nothing. Step Three asks me to consider turning all outcomes over to this Power; to live in the reality that I am not in control of how things work out in my life. I make choices and take action and leave the results to God. When I stop and think, I realize I am turning my will and my life over to the care of people I have never met. Yet, I did this on a daily basis while I was drinking and using with no thought of the consequences to myself or others. Turning my life over to the care of the Power of the Universe seems like a no brainer. I demonstrate my commitment to Step 3—my willingness to live in this Power’s will—by doing Steps 4-9. This Step is the beginning of a prayer of action that starts when I take the Step Three prayer and ends when I do the Seventh Step Prayer. I ask for this Power to care for me in a way I cannot care for myself, to relieve me of my little mindedness so that I have the needed power to work Step Four. This Third Step is so powerful, immense and pervasive because God takes it seriously even if I don’t. Even if I wander down a dark path, this Power remains steady and true to the decision I made. It was not until after taking this step that I became aware of all the things that I made higher powers in my life: money, the pursuit of money, having a relationship, sex, material possessions, what I thought, how I felt, what others did or did not do, etc.

So if you have done a Third Step and are wondering if what you are doing is in God’s will, if you are writing Fourth Step inventory, you can rest assured that you are, in fact, doing your Higher Power’s will. This Third Step is the beginning of a lifelong relationship with God as the keystone of the arch through which you will walk into a life beyond anything you can have imagine. -Charlotte S

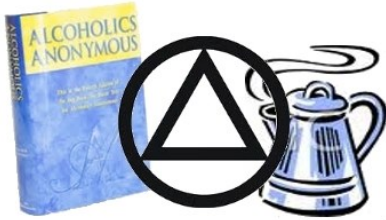

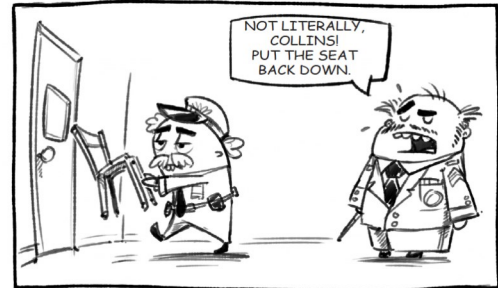
