

DANCED ALL NIGHT

Just when she thought she'd never have fun again, they turned the music up !

As I stood in the back of the room, holding my pregnant belly protectively, listening to an old man tell his story, all I could think of was, the fun is over.

I looked next to me and saw a homeless man drinking a cup of half and half that he got from the coffee table. I almost ran from the room screaming. I thought there was no way I could be an alcoholic. I was much too young. I didn't think I had anything in common with anyone in these meetings.

But that all changed. Thanks to my sponsor, when I reached three months of sobriety, I was asked to

tell my story. I stood up at the front of that meeting and, as I told my story, I saw people nodding their heads and laughing. I saw them relating to me and thought, Wow, I am an alcoholic. With that, a huge weight lifted off my shoulders. I knew what my problem was.

Soon I started to seek out people my age and talk with them. My home group was a Friday night meeting at 8:00 P.M. There were a lot of young people at the meeting and they kept asking me if I wanted to go get coffee afterward. I kept turning them down, saying I didn't drink coffee. I finally asked my sponsor why they kept asking me to go drink coffee, and she said, "Just go!"

So I went. We drank coffee and stayed up until 2:00 in the morning talking. It was amazing! I wondered,

What else do people do if they don't drink? I was about to learn.

That same group of young people invited me to go bowling, to the movies and to dinner, and I slowly learned how they lived without drinking—and had fun. The best part was that the next day I remembered everything I had said and done the night before!

One of the most fun events I attended in early sobriety was a sober "prom." The name of the prom was "A Prom for Those Who Never Went or Don't Remember Going." It was put on by the YPAA (Young People in AA) group. Everyone got dressed up and it looked and felt like a real prom.

Every year, our YPAA group held an AA New Year's dinner meeting and dance. I remember the first time I went in my first year of sobriety. I had never danced sober before. I was so nervous. I imagined everyone just sitting around not dancing, but boy was I wrong. Everyone was dancing! As I looked out at the crowd on the dance floor, I thought, These are all the people I wanted to party with when I was drinking. I quickly joined in and danced all night. I had found my people.

I now have 25 years of sobriety. A big part of my recovery is due to those early days when I learned that I could have a great time sober. I really thought my life was over. Instead, my life had just begun.

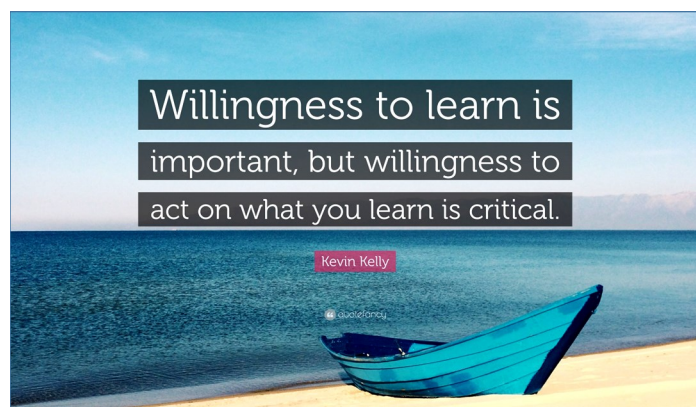

Tradition Six

An AA Group ought never endorse, finance or lend the AA name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose.

The best example I can give to understand this Tradition is those A.A. Members who are employed as Counselors in a Treatment Facility, Hospital, Rehab, or any outside agency that offers recovery for Alcoholism or any other substance abuse. The A.A. Members who are employed by these drying out spots in essence are wearing “two hats”. Tradition Six cautions them not to wear both hats at once! While employed at their jobs they may be Alcoholism Counselors; they are *not A.A. Counselors!* *When they are at an A.A. Meeting or at their A.A. Home Group, they are just A.A. Members, not Alcoholism experts.*

The same adage goes for the Hospital or Treatment Facility, the Hospital can't be called the Mercy Hospital and A.A. Facility. When I was about 3 years sober the two gentlemen who Twelfth Stepped me were going to form a new A.A. Group and he asked me if I would join up with them and be their General Service Representative. I agreed and the Pastor of the Church where we met did not want to charge our A.A. Group any Rent for our meetings. He said it was their Church's Community Service. Our Group Chairperson came up with the idea that every week during their Church Services, food for the poor would be brought to the church altar. We decided to purchase food that was mostly canned goods for the basket that would be taken to the altar every week. We would be ‘paying or way’ and the Church could never claim an affiliation with our Group or A.A. as a whole.

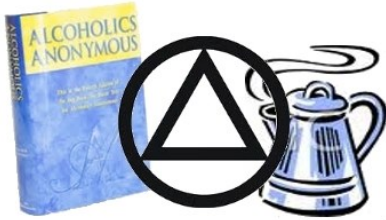
I also belonged to a Group in Ft. Myers, Florida that met in a Treatment Facility. They were a registered A.A. Group with our General Service Office in New York and they met two days a week in the Cafeteria at the Treatment Center. The Treatment Center wanted to supply Coffee, our Home Group said, “no”, we will bring our own Coffee. The Treatment Center did not want to charge the Group monthly Rent. The Group Conscience decided to make semi-annual Donation payments to the Treatment Center so they *could not claim affiliation with the A.A. Group or A.A. As a whole.*

North Central Intergroup Monthly Meeting

April 30, 2023

Open the meeting with a moment of silence and the Serenity Prayer – MC, Chair WELCOME!

Chair Report – MC: Asked everyone to keep putting out the word in our groups about having intergroup reps in the meetings and participation in the Intergroup monthly meeting.

Alt Chair Report - AB: Reiterated that people should spread the word about the Intergroup meeting and share out the service positions that are available. There are always opportunities for service.

Secretary report–KM, Secretary; JG, Alt Secretary: KM not present. March meeting minutes read, Motion to accept, second. Minutes accepted. (Apologies for not getting names of people who presented the motion and the second).

Treasurer Report – MR, Treasurer: April report was read, noted additional increases: Office manager’s salary was higher due to payment of social security tax and due to the large purchase of literature that was made to stock up before the prices increased. While more was spent than income received, the Treasurer noted that the balance is still in the black, as most money to cover Intergroup comes from the Gratitude Dinner, and there are still funds available. MR reiterated the preferred method of payment is Venmo as they do not charge a fee to the IG or the customer. HG asked about the small discrepancy of income noted on pages 6 and 7 of the POST, MR noted that there were two different ways to monitor income. W motioned to accept the report as read, D second. Treasurer’s report accepted.

Phone Committee – SS: Not present. Updates were relayed by IG Chair MC, via text. Current openings continue to be Monday 7am-10am; Tuesday 7am-10am; and Friday 7pm-10pm. Discussion was held about ways to garner interest in participating in the phone committee, including: holding a workshop about the phone positions and creating small flyers with easy to follow information about what to expect while monitoring the phone line. Several people shared their experience managing phone calls.

P.O.S.T. – TS: New POST is up to date and available, is working with MG to get her trained in all of the aspects of the POST. Requested articles to be written and submitted to be included in the POST. Three articles needed monthly: Cover Page (600-700 words), Inside articles (on step and tradition—about 300-350 words). POST submissions should be send in Word (ideally) or pdf (although not preferred by the 12th of the month to: post@aagainesville.org)

Office Manager - AO. Not present, MR shared in AO’s place. Ordered 5 cases of soft cover big books before the price increase and they are already gone. Will be increasing prices soon, to reflect new prices from NY, Books are going up 20% and pamphlets 30%. AO could use help in the office. Feel free to call or stop by to see how you can help.

Website – NL, Webmaster; TC, Alt Webmaster: NL not present. TC reported an updated zoom link to the New Sober Living noon meeting and will update the website with flyers he received earlier today.

DCM Report – EMH: Shared [DCM report](#), see notes. Big items: still need Alt DCM. Reviewed Treatment meeting needs, currently need support for Bridge House on the Fifth Wednesday of a month and Meridian Detox needs meetings on the 2nd Wednesday at 7pm. Chair noted that is the same day as District (6-7pm) so it may be creating a conflict.

*AR.. Shared about the [Women’s Retreat](#) on June 23-25, which will be held in Hawthorne. [Registration](#) starts May 1. Flyers were distributed and information will be posted on the website soon.

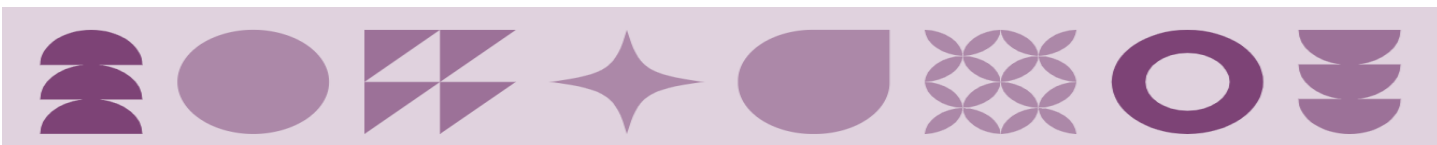

District 14 Meeting Minutes - April 12, 2023

We had a Big Book Quotes contest. The prize was a copy of the new book "Fun in Sobriety". Raffle won by DG. LL. was voted in as secretary and JM-P was voted in as alternate.

Treasurer-DC: Report approved as presented. Know that PayPal/Venmo accounts have been closed. Current IRS requirements would need to use the personal SS number of the current Treasurer and a filing of a 1099 form.

DCM Report: E encouraged GSRs to refer to aanorthflorida.org for information on Agenda items to be discussed at the next Area Assembly. Tradition of the month read. The concept of the Month was reviewed, the right of participation.

Accessibilities-S: S asks each group to choose an accessibility representative. She especially would like to have reps who would be able to evaluate their groups meeting location for accessibility requirements.

Archives-R: 6/10/23 will be Founder's Day. The topic is Women of AA, Lighting the Way. The planning committee will meet each Tuesday at 7 pm at the Triangle Club.

Corrections-N: There is a Keystone gentleman who is taking meetings into Bradford County jail. There were some monies provided for Big Books to take to prisoners there. Meetings are currently being held in Alachua County Jail and Lancaster correctional facility but they still need help (volunteers). Co-Webmaster, T, will provide a link for the application to visit correctional facilities on our District 14 website.

CPC/PI-S: No report.

Grapevine-B: Informational resources are being made available to GSR reps. Also, B will be checking on Grapevine availability for libraries in the Gainesville area.

Literature-J: Free literature obtained from GSO for Spanish speaking folks. Only had to pay shipping to receive this from Box 459, GSO. This will be available at Triangle Club and our AA office. Changes have been made to the AA Guidelines on Safety Card. More information will be forthcoming.

Treatment-K: 40 meetings are being covered currently.

- Need support for following meeting times at Bridge House: 7 pm each of following days- the 3rd Wednesday, 5th Wednesday and 3rd Thursday.
- Needed for Detox are 4 people (must have male & females in group) 7pm 2nd Wednesdays. Please contact K at the Treatment email provided on the website for more information.

Website-T: There is a group change form for change in GSR that can be filled out and sent to the webmaster. T will be providing an application form that needs to be filled out by anyone who wants to take meetings into jails/prisons.

Intergroup-M: Recognizing more members are physically showing up to monthly meetings. Phone Committee: SS continues to assist new leader MC. Current openings: Mondays 7 am to 10 am, Tuesdays 7 am to 10 am and Fridays 7 am to 10 am. Phone committee has a manual that can be forwarded through the internet to new people starting with the committee. Intergroup office: Some literature is still available at the old lower price. \$200.00 was received from Intergroup for Founder's Day.

Old Business: Need alternate DCM. Suggested guidelines: 3-5 years sobriety, previous GSR.

Treasurer: Last year, more was spent than contributed. After much discussion, the current budget was voted on and approved with one abstaining and one opposed. It was noted that any group could ask for an increase from their original budget amount as new needs become clear at any District 14 meeting.

District Business-E: Currently E has approval for monies for one night at Area Assembly. She now requests money to cover her two nights at Area Assembly. Motion agreed and passed without abstaining or opposition.

Intergroup would like the District to pay the cost of its two pages in the Post each month. The amount is 21.22 per 2 pages per month. Motion passed.

New Business:

Motion to forgo reading of the last month's minutes during the District Meeting. Motion passed.

Accessibilities chair requested \$170.00 for a workshop 5/20/23. This workshop will be put on by Corrections, Accessibility and Treatment. Approved without any abstaining or opposing.

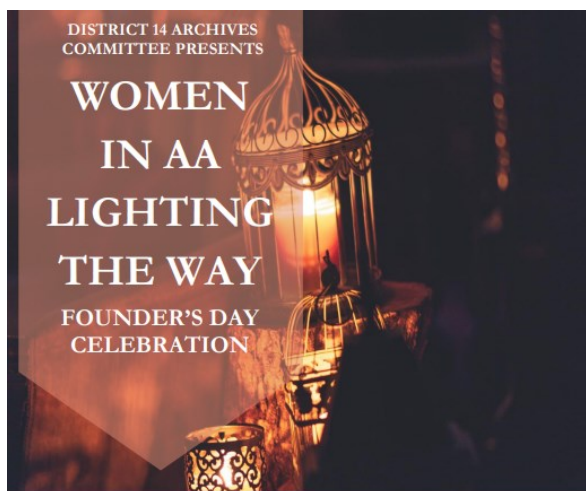
