The Way We Treat (

It took me decades to realize that the goal of recovery is sobriety and unconditional love of others and myself. I learned that a focused action plan based upon unconditional love provides specific behavioral objectives about what to do and what not to do.

My goals for recovery now are to be more unconditionally loving, kind, caring, giving, accepting, compassionate, tolerant, empathic, helpful, generous, patient, humble, honest, selfless, unselfish, other-centered, positive, altruistic and forgiving. I also seek to follow the Golden Rule—to treat others the way that I would really love them to treat me.

In addition, my aim is to be less selfish, selfcentered, judgmental, discriminatory, prejudicial, vain, egotistical, arrogant, perfectionistic, resentful, angry, fearful, anxious, hostile, envious, jealous, greedy and dishonest.

In other words, by first changing my behavior toward others, I started to feel better about myself because others began to treat me better. By changing my behavior I changed my feelings for the better. My thinking changed and improved as my feelings changed. The Big Book does not say, "Into Thinking." It says, "Into Action."

If I am ever concerned or confused about what to do, I ask myself this question: What is the loving thing to do here? Our cofounders Bill W. and Dr. Bob said the foundation of AA is love and if I am ever concerned or confused about what to do, I ask myself this question: What is the loving thing to do here?

Our cofounders Bill W. and Dr. Bob said the foundation of AA is love and service. I've learned that service is not just loving and helping people in AA; service is my loving behavior toward all people. The Twelfth Step indicates that I need to follow these principles in all of my affairs, not just some of them.

I also learned that humility is much better than trying to be great, to act great, to have great things and to show that I am great. That only drives people away. People don't care about any of this; they care about how I treat them. AA has taught me that being loving and humble works much better. Today I have serenity and peace of mind. This is what worked for me, and I hope it may help you too.

Step 9 can be incredibly difficult for those who may be struggling with feelings of shame, pride, or entitlement. But, as difficult as it is, completing this step can provide an immense sense of relief and newfound hope for the future. At the heart of this step is the need for forgiveness and restoration—forgiving yourself, forgiving others, and making amends. The ninth step is essential in the recovery journey.

After acknowledging how actions tied to our addictions had a negative impact on people in our lives, we commit to making direct amends whenever possible. For many of us, apologizing was a regular habit. Whether it was apologizing for being late for work, missing an event, misusing property or stealing money to support an addiction, expressing remorse was likely a daily occurrence. The guilt may have been real, but the apology didn't come with lasting change.

Making amends involves taking action to correct or repair our mistakes. This action can demonstrate the person's new way of life in recovery. It goes beyond simply apologizing. Whenever possible, we alcoholics are encouraged to make direct amends face-to-face with those we have harmed while living in addiction. For example, someone may make amends by apologizing for stealing property and then make it right by returning what they'd taken.

Along with reinforcing new behaviors and outlooks, making amends can also reduce stress. Many of us alcoholics have past behaviors we're not proud of. By proactively correcting previous mistakes, we help to prevent future conflicts that could trigger a relapse.



A.A., as such, ought never be organized, but we may create service boards or committees directly responsible to those they serve.

When this Tradition was first written it stated that "A.A. needs the least possible organization". Two things happened which contradicted our Society from not being organized. In my opinion, I believe our Co-Founder Bill W. (who wrote this Tradition) probably first wanted to appease the A.A. Groups who probably ran their own little fiefdoms. The second reason for this contradiction was that after March 1941 our Group membership grew twofold.

The key to this Tradition is by simply looking at our Service structures "Upside Down Triangle". The A.A. Groups when they form adopt a set of By-Laws to run the Group. The By-laws conform to our A.A. Traditions. Most Groups use Tradition V as their pivot when they form. They then hold their first Group Conscience meeting using our Second Tradition. The Group then elects Trusted Servants to hold Group Service Positions and they perform their prospective duties for the Group as a whole. The Group holds A.A. Business meetings and the Meetings as well as the voting are democratic. When voting on a Motion even the losing side of the Vote is given a Voice (Concept V)! This is truly Democracy at work.

When our General Service Office grew to our increased Membership different Departments sprang up to handle Group Services, Big Book Sales, Where and When to find A.A. Groups, and lo and behold Committees were formed!

A.A. today has many committees at the Group, Intergroup, District, Area and when a General Service Conference Committee is formed each Area Delegate is assigned to a Conference Committee to vote on that year's (Panel) selected Agenda Items. The General Service Conference selected me to serve on the Finance Committee in 2009 (Panel 59). The Finance Committee that year elected me to Chair the Delegate's Finance Committee in 2010(Panel 60).

In A.A. today sometimes a topic of special interest will occur within a Group, Intergroup, District, Area or even at the General Service Conference. An Ad Hoc Committee is formed to research the Subject and report their findings and results to the Service entity that assigned the Ad Hoc Committee.




