

The Trouble with Fear



When danger is imminent, fear can be a fight-or-flight lifesaver. AA's 4th Step in the *Twelve Steps and Twelve Traditions* book says that human instincts are necessary for our existence, and that "nearly every serious emotional problem can be seen as a case of misdirected instinct." AA has helped me realize that most of my fears are habits leftover from childhood. My refusal to face, feel and own them caused me years of needless misery.

Since coming into AA and staying sober, I've learned to deeply question fear, practice solutions instead of problems, sanity instead of insanity, love instead of fear. Otherwise, fear can ruin this moment, this day, this life—if I let it. I don't *have to let it*.

In sobriety, I've sometimes tasted a glorious world of freedom beyond fear and the unstoppable power of love and responsible adult conduct—even while feeling like a scared little kid. At those times, I've tried to remember solutions, breathe deeply, say heartfelt prayers, take a Third Step, write down specific fears,

call my AA sponsor, take a nature walk, do something for someone else, practice "constructive imagination" (p.100) not mental horror movies, let go. I also love a simple quote I read somewhere: "Look for the good and leave the rest to God."

My world is no bigger than this moment. This means that right now, my world is just me sitting here at a desk typing words that magically appear on a computer screen. If any fear comes up, it would be an irrational fear since I'm perfectly safe right now. There's no danger. All is well.

Years ago, I heard a priest say, "Life isn't what's coming out of a box called television. That's not life. Life is what's going on in the room where you're watching television." AA says, "There is One who has all power, that One is God, may you find Him now." I've learned to pay attention. Now means now. "Courage isn't the absence of fear, but rather a judgment that something else is more important than fear."

Continued to take personal inventory and when we were wrong promptly admitted it.

In step 10, personal inventory refers to emotional disturbances that can trigger a person to return to misusing drugs or alcohol. Watching for these disturbances on a daily basis—and taking a daily inventory—is an important part of recovery. **The daily work of step 10 is ongoing.** There's no simple switch to flip. You will have situations in your daily life that don't make living Step 10 easy at all. Sometimes, you may not be able to instantly control your thoughts and actions. However, Step 10's about learning with each instance that you have the ability to right your thought patterns and correct your actions.

View this step as a process of ongoing honesty. It's about showing your vulnerabilities and exposing the part of you that you don't want others to know about, the darker, perhaps angry part of yourself. That's how you'll take inventory. As you go through your day, you may recognize a situation that really angers you. If you step away for a moment, you can see that your reaction may not be the right one. In that thought process, you come to grips with yourself and your deep emotions.

As you work this process each day, take the time to think about your inventory and notice any trends. Is there something constantly on your inventory? Is there some experience that happens numerous times? If that's the case, it means you are truly not working Step 10 enough.

To be successful, you must not just recognize the mistake; you must also admit that it was wrong. When you decide that it is wrong, you work consciously and with defined actions to fix it and stop it from occurring again. Any time you notice this type of repetitive mistake, you haven't truly worked through it yet.

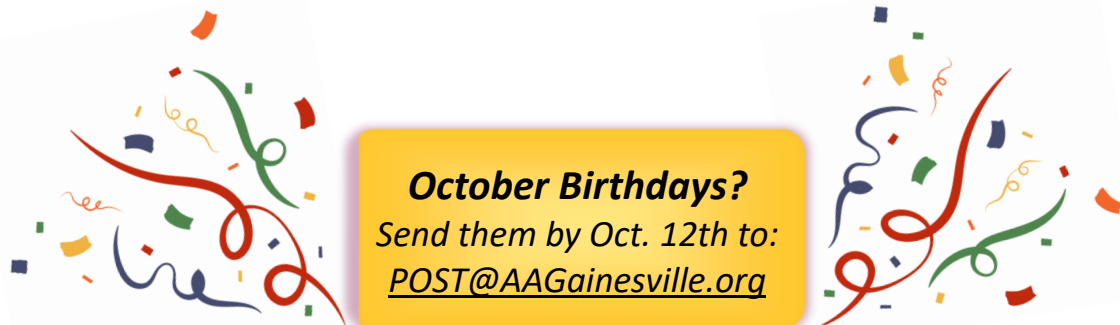

*Alcoholics Anonymous has no opinion on outside issues;
hence the A.A. name ought never be drawn into public controversy.*

This is a Tradition that fortunately has not been a major issue to Alcoholics Anonymous. Since our Fellowship's inception, we have never had our ranks split by a controversial issue. A.A. has been, and always will be about shared experience. One of our Co-Founders Bill W., was approached in the early 1940's regarding a movement that sprang up in the United States a century before. This Tradition came to fruition and was a direct result of a Society known as the Washingtonian Movement.

The Washingtonian Movement became a Society and started in Baltimore, Maryland in 1840. They had reached a membership of at their peak of approximately 600,000* members and within a few years most of their groups had disbanded. They started out with seven similarities to Alcoholics Anonymous. The similarities were:

1. Alcoholics helping each other.
2. The needs and interests of alcoholics kept central, despite mixed membership, by predominance in numbers, control, or the enthusiasm of the movement.
3. Weekly Meetings.
4. The sharing of experiences.
5. The Fellowship of the Group or its members constantly available.
6. The reliance upon the power of God.
7. Total abstinence of alcohol.

Does this sound familiar? Here are some of the differences that led to their demise:

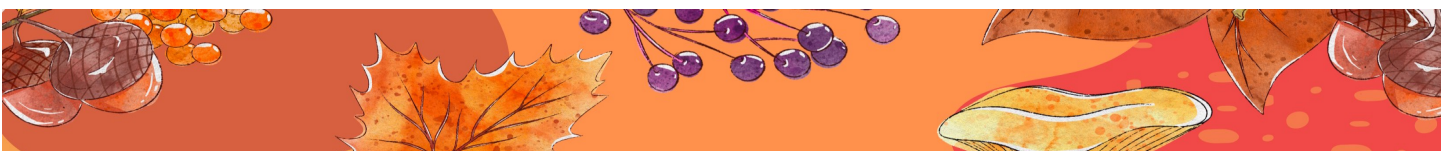
1. The admission of non-alcoholics as members.
2. The incorporation of the "Temperance Purpose", the inducement of total abstinence in non-alcoholics became two of the most striking differences.
3. The 1840's were a Pre-Civil War era and many of the Groups that were in the southern U.S. States began a Pro-Slavery stand. The Groups in the northern States adopted an Abolitionist platform. These ideas were conveyed by their speakers at the podiums and their leaders in their Home Group meetings.
4. Many of the speakers at these meetings were paid and Abraham Lincoln even spoke at a meeting in 1842 when he was a Congressman in Illinois. He was not a member of the Society but was the Guest Speaker on February 22, 1842 which also happens to be George Washington's Birthday.

What can prevent this sort of thing from happening today? From time to time an A.A. Group should take its Group Inventory by learning the A.A. Traditions and what they really mean. The A.A. pamphlet *The A.A. Group...where it all begins*. This is probably the most comprehensive pamphlet published by our General Service Office.

Note: The U.S. Resident Population in 1840 was 17,063,353 (Source taken from U.S. Census Bureau).

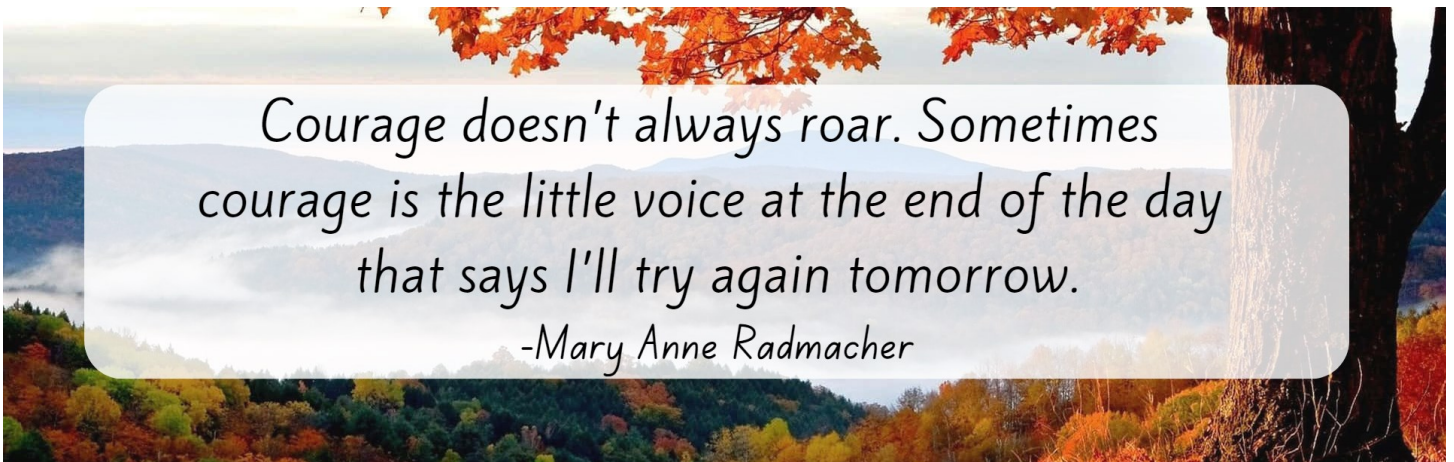
