Talk about "bleeding deacons" vs. "elder statesmen" and "learning to let go" permeated the air as A.A.'s attending the 1983 Northeast Regional Forum in Somerset, NJ., gathered for a lively and candid session on "Rotation: Its Implications in Our Area." Presentations by Conference delegates touched on many aspects. Noting that rotation is "the main method we have to prevent power, prestige, and personal recognition from distorting our best intentions," Maine delegate Frank R. stressed its importance in putting "a check valve on these intentions." Since rotation in all service positions from the board of trustees to G.S.O. to the group level limits the length of individual service, "It also gives the newcomer a chance to serve," Frank said.

Dick D., a delegate from New Hampshire, said his introduction to rotation occurred when "I was asked to stop being my group's coffee maker. That's when I learned you have to give it away to keep that beautiful feeling!" Since then, Dick has rotated out of several service slots, often with reluctance. "But learning to let go has meant personal growth for me," he maintained. "I only hope that when it's time to rotate out of this delegate job, I'll become an elder statesman and not a bleeding deacon!"

His experience recalls the words of a former G.S.O. general manager, Bob H., in a Conference talk on the subject of rotation: "When [servants in A.A.] rotate out of office, they're obeying' the letter of the law,' but are they obeying its spirit if they still try to run the show? The inability to let go can become something close to an illness. Sometimes, these unfortunate folk need help in learning to really step down. We may even have to pry their hands from the helm, figuratively. But whatever needs doing to make them let go, do it! You'll be doing everyone concerned a favor, including the reluctant ex-servant."

He reminded his fellow A.A. servants that "rotation is practiced not to put somebody out of a job, but to ensure that the selfish ones do not hold on, and that all have an opportunity to serve." Furthermore, he said with a wide grin, "Rotation also limits the time for those of us who serve to mess things up!"

"The more informed people there are to carry the A.A. message, the faster and further it will be carried," she said. Without the principle of rotation, she noted, responsibility for carrying the message would rest in the hands of just a handful of people, thus causing the Fellowship to become alienated from our Third Legacy of Service.

The 1st Step says: "We admitted we were powerless over alcohol." It does not say we were powerless over our choices, over our lives, or over our relationships with other people. It says we were powerless over alcohol, and that limiting phrase, that tight focus on the drug, is critical. In order to break our addiction, we have to admit that we can't change what it does to us. It affects our brain, our body, and our spirit, and there's no sense in denying it. We're powerless over the effect the chemical or behavior has on us. We're not going to get good at drinking or drugging, we're not going to get more rational about it. We're not going to get better at controlling. We've tried it a hundred times already.

What about Unmanageable? My Life Is Going Pretty Smoothly... Unmanageability should also be defined more tightly, because the person who has a great job or a loving spouse or a nice home might say, "My life feels pretty manageable, actually." They might look at everything that's going well and completely resist the idea that life is no longer manageable. And that's only fair and natural. But the terminal stages of addiction will strip everything away, and an addicted person who refuses to recover will often be left with nothing. There's a simpler way to think of unmanageability: drinking or using drugs is causing problems in a person's life. Maybe life hasn't become fully unmanageable yet, but a person has lost friends or romantic partners because of their addiction, or they face criminal punishment or work-related consequences and they continue to use. The warning signs are there, and it might not be unmanageable now, but it will be.

So What Is the First Step Asking For?.. The main criterion for a successful First Step is a person's acceptance that they do, indeed, have the disease of addiction. A person shouldn't consider themselves weak-willed or incapable when they admit to their powerlessness, and they don't have to do anything about their addiction yet. Step One is just asking a person to acknowledge that they have the disease of addiction, and life is harder because of it.



This Month's Tradition will include an introduction and how vitally important the A.A. Traditions are today for our Society's survival. Bill W., our Co-Founder, started writing the A.A. Traditions in the mid-1940s because A.A. was in trouble with what Bill W. liked to describe as "menacing factions" from within and "menacing factions" from without. As A.A. began to grow, many groups adopted their own set of membership rules. The money collected in the baskets was coming from outside of A.A., and there were always inquiries sent to the Home Office in New York about how the groups could keep operating. What should we do about A.A. Clubhouses that were opening up? There were also a large number of member anonymity breaks at the public level. When those members got drunk, A.A. didn't pose itself as a viable source for recovery from alcoholism.

Bill W. started introducing the Twelve Traditions in the A.A. Grapevine in 1946. He titled them in the A.A. Grapevine as "Twelve Points to Assure Our Future." The Twelve Traditions were confirmed at our First International Convention in 1950. The book titled Twelve Steps and Twelve Traditions was published in 1953. The 12 Steps of A.A. are our message. The 12 Traditions protect our message, and the 12 Concepts perpetuate our message.

When an act of Providence finally put two alcoholics to acknowledge their desperation and find recovery on the evening of May 12, 1935, the next day, Bill W. and Dr. Bob set out to find other alcoholics in order to stay sober themselves. They found Bill D. in Akron City Hospital, and when he walked out of the hospital on July 4, 1935, the first group was formed. The Oxford Group meetings Dr. Bob attended over the past two years created a "splinter" group, and they met separately. They were called the "Drunk Squad" by the Oxford Groupers. The New York Oxford Group (where Bill W. formed a group) "Drunk Squad" broke away and met separately in 1937. The Akron Oxford Group "Drunk Squad.' broke away from the Oxford Group in December 1939, and that group was renamed "Alcoholics Anonymous" after the book of the same name that was published in April of that same year. The group met first at Dr. Bob's home and then found a school where they met a short time later.

This tight-knit little group looked out for each other, and today, I can't think of any other organization that cares more about the health and well-being of its members. Bill W. probably said it best, "We stay whole, or A.A. dies." In many A.A. Home Groups today, members from all walks of life check their egos at the door and sacrifice themselves by doing menial tasks to help the group operate and prepare for those yet to come. No A.A. member can compel another member to do anything. No one can be punished or expelled. The moment that twelfth step work forms an A.A. Group, another discovery is made: that most individual A.A. members can't recover unless there *is* a group. Bill W. also wrote, "It becomes plain that the group must survive or the individual will not."


